##### *Enforcement of repairing standard*

### 23 [F<sup>1</sup>Consideration of applications]

- (1) [F<sup>2</sup>The Chamber President] must decide whether to—
- refer an application under section 22(1) [F<sup>3</sup>or 22(1A)] to [F<sup>4</sup>the First-tier Tribunal] , or
  - reject the application.
- (2) The [F<sup>5</sup>Chamber President] may reject an application only if the [F<sup>5</sup>Chamber President] considers—
- that it is vexatious or frivolous,
  - where the tenant [F<sup>6</sup>or third party applicant] has previously made an identical or substantially similar application in relation to the same house, that there has not been a reasonable period of time between the applications, or
  - that the dispute to which the application relates has been resolved.
- (3) The [F<sup>7</sup>Chamber President] must make a decision under subsection (1)—
- within 14 days of the [F<sup>8</sup>First-tier Tribunal's] receipt of the application concerned, or
  - where the [F<sup>9</sup>Chamber President] considers—
    - that the decision cannot be made without further information, or
    - that there is a reasonable prospect of the dispute being resolved by the parties,by such later date as the [F<sup>10</sup>Chamber President] considers reasonable.

- (4) The [<sup>F11</sup>Chamber President] must, as soon as practicable after rejecting an application [<sup>F12</sup>under section 22(1)] give notice of the rejection—
- (a) to the tenant, and
  - (b) where the [<sup>F11</sup>Chamber President] is aware of the name and address of a person who acts for the tenant in relation to the application, to that person.
- [<sup>F13</sup>(4A) The [<sup>F14</sup>Chamber President] must, as soon as practicable after rejecting an application under section 22(1A) give notice of the rejection to—
- (a) the third party applicant, and
  - (b) the tenant.]
- (5) [<sup>F15</sup>A notice under subsection (4) or (4A)] must—
- (a) set out the reasons for the rejection, and
  - (b) explain the procedure for appealing against it.
