Citation, commencement and interpretation

- 1.—(1) This order may be cited as the General Register Office (Fees) Order (Northern Ireland) 2012 and shall come into operation on 3rd December 2012.
- (2) The Interpretation Act (Northern Ireland) 1954(**d**) shall apply to this Order as it applies to an Act of the Assembly.

Fees payable

2. The fee payable under a statutory provision specified in column 1 of the Schedule in respect of the matter specified in relation to it in column 2 shall be the fee specified in relation to it in column 3.

3. The General Register Office (Fees) Order (Northern Ireland) 2010(e) is hereby revoked.
