## Transitional Regulations.

REGULATIONS, DATED 31ST DECEMBER, 1930, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 23 OF THE NATIONAL HEALTH INSURANCE ACT, 1928, AS APPLIED TO NORTHERN IRELAND BY THE NATIONAL HEALTH INSURANCE ACT (NORTHERN IRELAND), 1928, AND THE NATIONAL HEALTH INSURANCE (EXTENSION OF ENACTMENTS) ORDER (NORTHERN IRELAND), 1928.

## 1930. No. 176.

The Ministry of Labour for Northern Ireland, in exercise of the powers conferred on it by Section 23 of the National Health Insurance Act, 1928, as applied to Northern Ireland by the National Health Insurance Act (Northern Ireland), 1928, and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1928, made thereunder, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the National Health Insurance Transitional Regulations (Northern Ireland), 1930.
- (2) These regulations shall come into operation on the first-day of January, 1931.
- 2.—(1) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them:—
  - "The principal Act" means the National Health Insurance Act, 1924.
  - "The Act of 1928" means the National Health Insurance Act, 1928, as applied to Northern Ireland by the National Health Insurance Act (Northern Ireland), 1928, and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1928.
  - "The Ministry" means the Ministry of Labour for Northern. Ireland.
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

3. Where a person, to whom Section 23 of the Act of 1928 refers, was on the 31st December, 1930, insured as an employed contributor under the provisions of sub-section (3) of Section three of the principal Act, or under the said sub-section as applied by Regulations made under Section 23 of the Act of 1928, he shall continue to be treated as an employed contributor remaining by virtue of the said sub-section insured under the principal Act until the thirtieth day of April, 1931, if he satisfies the requirement contained in paragraph (a) of the said sub-section, and also proves, within such time as may be determined by the Ministry, that throughout the period during which, by virtue of the said subsection he remained insured under the principal Act he was when not employed within the meaning of that Act either available for, but unable to obtain, employment within the meaning of the principal Act, or incapable of work by reason of some specific disease or bodily or mental disablement of which notice was given within the time prescribed in Article 3 of the National Health Insurance (Duration of Insurance) Regulations, 1929.
