HOUSING ON FARMS

Grants in respect of farmhouses and of approved workers' houses

Order*, dated 2nd November, 1964, made by the Ministry of Health and Local Government, with the approval of the Ministry of Finance, under section 12 of the Housing on Farms Act (Northern Ireland) 1950.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry"), with the approval of the Ministry of (Finance, in exercise of the powers conferred on the Ministry by section 12 of the Housing on Farms Act (Northern Ireland) 1950(a) (in this Order referred to as "the Act"), and of every other power it thereunto enabling, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Housing on Farms (Grants) Order (Northern Ireland) 1964, and shall, subject to the provisions of sub-section (4) of section 12 of the Act, come into operation on the 1st January, 1965.

Grants for provision of new farmhouses

2. The amount of grant payable under section 1 of the Act in respect of a new farmhouse completed before the 1st January, 1967, in accordance with plans submitted to and approved by the Ministry before the 1st January, 1966, and falling within any one of the categories mentioned in the first column of the First Schedule shall be the amount specified opposite such category in the second column of the said Schedule.

Grants for provision of houses for approved workers.

3. The amount of grant payable under section 4 of the Act in respect of an approved worker's house completed before the 1st January, 1967, in accordance with plans submitted to and approved by the Ministry before the 1st January, 1966, and falling within any one of the categories mentioned in the first column of the Second Schedule shall be the amount specified opposite such category in the second column of the said Schedule.

Grants for reconditioning premises as farmhouses or approved workers' houses

4. The amount of grant payable under section 7 of the Act in respect of the reconditioning of any premises for use as a farmhouse or approved worker's house completed before the 1st January, 1967, in accordance with plans submitted to and approved by the Ministry on or after the 4th February, 1955, and before the 1st January, 1966, and falling within any one of the

categories mentioned in the first column of the Third Schedule shall be the amount specified opposite such category in the second column of the said Schedule.

THIRD SCHEDULE

Category of House	Amount of Grant payable by the Ministry
Reconditioning of premises for occupation as farmhouses or approved workers' houses	(a) a sum of £400; or (b) a sum equal to the aggregate of two-thirds of that part of the approved cost of reconditioning which exceeds £75 and does not exceed £525 and one-half of that part, if any, which exceeds £525; whichever is the lesser.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

The object of this Order is to extend to the 1st January, 1966, the date before which plans for the provision of houses and the reconditioning of premises as houses on farms must be submitted to the Ministry of Health and Local Government for approval in order to qualify for grant.

The Order also prescribes the rates of grant payable in respect of new farmhouses, approved workers' houses, and reconditioning works, and prescribes the dates before which work must be completed in order to qualify for the rates of grant specified.

ANIMALS

Prevention of Cruelty

ORDER, DATED 14TH DECEMBER, 1964, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 1D OF THE PROTECTION OF ANIMALS ACT 1911.

Whereas the Ministry of Home Affairs in exercise of the powers vested in it by Section 1D of the Protection of Animals Act 1911(a) made an Order entitled the Spring Traps Approval (No. 2) Order (Northern Ireland) 1961(b) approving the gin trap for the period of one year from the 1st January, 1962, (hereinafter referred to as the principal Order) for the purpose only of killing or taking foxes, provided that it shall be securely pegged or fastened at the site and the person who sets or causes or procures the trap to be set shall inspect or cause some competent person to inspect the trap at least twice every day, one inspection to take place between 4 a.m. and 10 a.m. and one between 4 p.m. and 10 p.m.

And whereas the principal Order has been continued in force from time to time for further periods of one year and will expire at the end of December, 1964.

And whereas it is expedient to provide for the continuance of the principal Order for a further period of one year.

Now, therefore, the Ministry of Home Affairs, in exercise of the powers vested in it by Section 1D of the Protection of Animals Act 1911 and of all other powers enabling it in that behalf, and after consultation with the Ministry of Agriculture, hereby makes the following Order:
