# The Scottish Parliament (Disqualification) Order 2020

*Made - - - - 14th October 2020* 

Coming into force - - 15th October 2020

At the Court at Windsor Castle, the 14th day of October 2020

Present,

The Queen's Most Excellent Majesty in Council

This Order is made in exercise of the powers conferred by section 15(1) and (2) of the Scotland Act 1998(a), and all other powers enabling Her Majesty to do so.

In accordance with section 115(1) and paragraphs 1 and 2 of schedule 7 of that Act, a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament(**b**).

Accordingly, Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows:

#### Citation and commencement

**1.** This Order may be cited as the Scottish Parliament (Disqualification) Order 2020 and comes into force on the day after the day on which it is made.

#### **Specified office-holders**

- **2.** An office-holder of a description specified in Part 1 of the schedule is disqualified from being a member of the Scottish Parliament.
- **3.** An office-holder of a description specified in column 1 of Part 2 of the schedule is disqualified from being a member of the Scottish Parliament for any constituency specified in relation to that office-holder in column 2 of that Part of the schedule and for any region specified in relation to that office-holder in column 3 of that Part of the schedule.
