Appeals

36 Appeals to [^{F1}Supreme Court].

- (1) In the ^{M1}Criminal Appeal Act 1968, in—
- section 33(1) (right of appeal to House of Lords), and
 - section 36 (bail),
- after “1987” there shall be inserted “ or section 35 of the Criminal Procedure and Investigations Act 1996 ”.
- (2) The judge may continue a preparatory hearing notwithstanding that leave to appeal has been granted under Part II of the Criminal Appeal Act 1968, but [^{F2}the preparatory hearing shall not be concluded] until after the appeal has been determined or abandoned.
