SCHOOL ATTENDANCE

School attendance orders

441 Choice of school: child with [^{F1}EHC plan][^{F2}or statement of special educational needs].

(1) Subsections (2) and (3) apply where a [^{F3}local authority][^{F4}in England] are required by virtue of section 437(3) to serve a school attendance order in respect of a child for whom they maintain [^{F5}an EHC plan [^{F6}(in the case of a local authority in England) or] a statement under section 324 [^{F7}(in the case of a local authority in Wales)]].

(2) Where the [^{F8}EHC plan][^{F9}or statement] specifies the name of a school, that school shall be named in the order.

(3) Where the [^{F10}EHC plan][^{F11}or statement] does not specify the name of a school—
(a) the authority shall, ^{F12} . . . , amend the [^{F13}EHC plan][^{F14}or statement] so that it specifies the name of a school, and
(b) that school shall then be named in the order.

[^{F15}(3A) [^{F16}An amendment to a statement required to be made under subsection (3)(a) shall be treated for the purposes of Schedule 27 as if it were an amendment proposed following a periodic review (within the meaning of that Schedule).]]

[^{F17}(3B) An amendment to an EHC plan required to be made under subsection (3)(a) shall be treated as if it were an amendment made following a review under section 44 of the

(4) Where—

- (a) a school attendance order is in force in respect of a child for whom the [^{F3}local authority] maintain [^{F18}an EHC plan]]^{F19}or a statement under section 324], and
- (b) the name of the school specified in the [^{F20}plan]]^{F21}or statement] is changed, the [^{F3}local authority] shall amend the order accordingly.
