

Preliminary

19 Special measures direction relating to eligible witness.

- (1) This section applies where in any criminal proceedings—
 - (a) a party to the proceedings makes an application for the court to give a direction under this section in relation to a witness in the proceedings other than the accused, or
 - (b) the court of its own motion raises the issue whether such a direction should be given.

- (3) In determining for the purposes of this Chapter whether any special measure or measures would or would not be likely to improve, or to maximise so far as practicable, the quality of evidence given by the witness, the court must consider all the circumstances of the case, including in particular—
 - (a) any views expressed by the witness; and
 - (b) whether the measure or measures might tend to inhibit such evidence being effectively tested by a party to the proceedings.

29 Examination of witness through intermediary.

- (5) A person may not act as an intermediary in a particular case except after making a declaration, in such form as may be prescribed by [F55Criminal Procedure Rules], that he will faithfully perform his function as intermediary.

 - (c) use of a live link would enable him to participate more effectively in the proceedings as a witness (whether by improving the quality of his evidence or otherwise).
- (6) While a live link direction has effect the accused may not give oral evidence before the court in the proceedings otherwise than through a live link.
- (7) The court may discharge a live link direction at any time before or during any hearing to which it applies if it appears to the court to be in the interests of justice to do so (but this does not affect the power to give a further live link direction in relation to the accused).

The court may exercise this power of its own motion or on an application by a party.

TRANSITIONAL PROVISIONS AND SAVINGS

Interpretation

1 (1) In this Schedule—

"the 1988 Act" means the M92 Criminal Justice Act 1988;

"commencement date", in relation to any provisions of this Act and proceedings of any description, means the date on which those provisions come into force in relation to such proceedings;

"continuing proceedings" (except in paragraph 3) means proceedings instituted before the commencement date;

"existing special measures power" means any power of the court to make an order or give leave, in the exercise of its inherent jurisdiction, for the taking of measures in relation to a witness which are similar to those which could be provided for by a special measures direction.

- (2) For the purposes of this Schedule—

 - (b) proceedings on appeal are to be taken to be instituted at the time when the notice of appeal is given or (as the case may be) the reference under section 9 or 11 of the M94Criminal Appeal Act 1995 is made.
