THE COMMISSION FOR EQUALITY AND HUMAN RIGHTS

Interpretation

34 Unlawful

- (1) In this Part (except section 30(3)) “unlawful” means contrary to a provision of the [^{F1}Equality Act 2010].
- (2) But action is not unlawful for the purposes of this Part by reason only of the fact that it contravenes a duty under or by virtue of [^{F2}any of the following provisions of the Equality Act 2010]—
 - [^{F3}(a) section 1 (public sector duty regarding socio-economic inequalities),
 - (b) section 149, 153 or 154 (public sector equality duty),
 - (c) Part 12 (disabled persons: transport), or
 - (d) section 190 (disability: improvements to let dwelling houses).]
