 - (b) for "court" substitute "[F1Secretary of State]",
 - (c) omit "the [F1Secretary of State] or", and
 - (d) in paragraphs (a) and (b), for "the order under section 39B" substitute "the disqualification order".
 - (3) After that subsection insert—
 - "(1A) The power conferred by subsection (1) shall be exercisable by the court instead of by the [F2Secretary of State] at any time when an appeal brought under section 39CB against the order has not been determined, withdrawn or discontinued."
 - (4) In subsection (2)—
 - (a) for "an order under section 39B" substitute "a disqualification order",
 - (b) for "court" substitute "[F3Secretary of State]",
