**The Criminal Justice and Police Act 2001 (Commencement  
No. 9) Order 2003**

*Made - - - - - 13th March 2003*

In exercise of the powers conferred upon him by section 138(2) of the Criminal Justice and Police Act 2001(a), the Secretary of State hereby makes the following Order:

**1.** This Order may be cited as the Criminal Justice and Police Act 2001 (Commencement No. 9) Order 2003.

**2.** The following provisions of the Criminal Justice and Police Act 2001 shall come into force on 1st April 2003—

- (a) sections 50 to 63;
- (b) section 64(1) save for the words “subject to subsection (2),”;
- (c) sections 65 to 70;
- (d) section 73;
- (e) section 74;
- (f) section 78(2);
- (g) section 79;
- (h) section 80(1);
- (i) section 137 in so far as it relates to the entries in Schedule 7 referred to in paragraph (m) below;
- (j) Schedule 1 save for paragraphs 35, 42 and 67;
- (k) Schedule 2 to the extent not already in force;
- (l) Schedule 5; and
- (m) Schedule 7, Part 2 to the extent not already in force.
