# The Local Elections (Northern Ireland) Order 2010

#### Citation and commencement

- 1.—(1) This Order may be cited as the Local Elections (Northern Ireland) Order 2010.
- (2) This Order comes into force on the day after the day on which it is made.
- (3) This Order does not apply to an election to fill a casual vacancy in a district council that occurred (within the meaning of section 11(5) of the 1962 Act M1) on or before the day on which this Order comes into force.

### Interpretation

**2.**—(1) In this Order—

"the 1962 Act" means the Electoral Law Act (Northern Ireland) 1962 M2;

"Local Elections Rules" means the rules in Schedule 5 to the 1962 Act M3; and

"the 1985 Order" means the Local Elections (Northern Ireland) Order 1985 M4.

(2) The Interpretation Act (Northern Ireland) 1954 M5 applies to Article 1 and this Article and the following provisions of this Order as it applies to an Act of the Assembly.

**3.** In 2011 the election day (within the meaning of section 11(1) <sup>M6</sup> of the 1962 Act) is the first Thursday in May (5th May).

- **6.**—(1) The Schedule to the Elections Act 2001 M7 is amended as follows.
- (2) In paragraph 23 (voting by persons with disabilities)—
  - (a) for "paragraph (4)" substitute "paragraph (4A)"; and
  - (b) renumber the inserted paragraphs (4A) and (4B) so that they become paragraphs (4B) and (4C).
- (3) In paragraph 28 (countermand or abandonment of poll on death of candidate)—
  - (a) omit sub-paragraph (1);
  - (b) in sub-paragraph (2)—
    - (i) for "After paragraph (1)" substitute "In rule 63 after paragraph (2)"; and
    - (ii) renumber the inserted paragraph (1A) as paragraph (2A); and
  - (c) in sub-paragraph (3) for "For paragraph (2)" substitute " In rule 64, for paragraphs (2) to (6) substitute".
