The Secretary of State makes the following Regulations in exercise of the powers conferred by section 66 of the Children and Social Work Act  $2017(\mathbf{a})$ :

### Citation and commencement

**1.** These Regulations may be cited as the Children and Social Work Act 2017 (Consequential Amendments) (Social Workers) Regulations 2019 and come into force on the date on which section 39(1) of the Children and Social Work Act 2017 comes into force(**b**).

### EXPLANATORY NOTE

### (This note is not part of the Regulations)

Part 2 of the Children and Social Work Act 2017 ("the Act") made changes to the way in which social workers in England are regulated. In particular, the Act established a body corporate, Social Work England, as the regulator of social workers in England in place of the Health and Care Professions Council. The Act made amendments to primary legislation consequent on the change of regulator, and to the Health Professions Order 2001 (S.I. 2002/254) ("the 2001 Order") which regulates the Health and Care Professions Council, including to amend the title of the 2001 Order (which was previously the Health and Social Work Professions Order 2001).

The Social Workers Regulations 2018 (S.I. 2018/893) ("the principal Regulations") are made under Part 2 of the Act. They make provision about the functions of Social Work England in relation to social workers in England, including maintaining the register of social workers and the approval of eduction and training courses.

These Regulations, which come into force at the same time as the principal Regulations (on the date on which section 39(1) of the Act comes into force), make consequential amendments to secondary legislation to reflect the transfer of functions to Social Work England and the change to the title of the 2001 Order.

Schedule 1 makes consequential amendments to Orders of Council made under the 2001 Order, Schedule 2 makes amendments consequential on the renaming of the 2001 Order, and Schedule 3 makes amendments consequential on the transfer of functions in relation to social workers.

No impact assessment has been prepared for this instrument.
