The Minister of Health and the National Health Insurance Joint Committee, acting jointly so far as regards regulations which the said Joint Committee is empowered to make jointly with the Minister, and the Minister so far as regards regulations which he is empowered to make alone, in pursuance of the powers conferred on them by Section 134 of the Factory and Workshop Act, 1901, Section 91 of the Unemployment Insurance Act, 1935, Section 135 of the Education Act, 1921, Section 180 of the National Health Insurance Act, 1936, the last-mentioned Section as applied by subsection (3) of Section 33 of the Widows', Orphans' and Old Age Contributory Pensions Act, 1936, and subsection (5) of Section 50 of the Unemployment Act, 1934, hereby make the following regulations:—

- 1. These regulations may be cited as the Certificates of Births, Deaths and Marriages (Requisition) Regulations, 1937.
- 2. The Interpretation Act, 1889, applies to the interpretation of 52 & 53 Vict. these regulations as it applies to the interpretation of an Act of Parlia- c. 63. ment.
- 3. The requisition to be made to entitle any person to obtain a certified copy of an entry in a register of births under the provisions of Section 134 of the Factory and Workshop Act, 1901, Section 91 of the Unemployment Insurance Act, 1935, Section 135 of the Education Act, 1921, subsection (1) of Section 180 of the National Health Insurance Act, 1936, the last-mentioned subsection as applied by subsection (3) of Section 33 of the Widows', Orphans' and Old Age Contributory Pensions Act, 1936, and subsection (5) of Section 50

of the Unemployment Act, 1934, shall be in the form A set forth in the schedule to these regulations or a form substantially to the like effect.

- 4. The requisition to be made to entitle any person to obtain a certified copy of an entry in a register of deaths under the provisions of Section 91 of the Unemployment Insurance Act, 1935, and subsection (5) of Section 50 of the Unemployment Act, 1934, shall be in the form B set forth in the schedule to these regulations or a form substantially to the like effect.

- 5. The provisions of Section 97 of the Friendly Societies Act, 1896, shall apply to certificates of the death of insured persons required for the purposes of the Widows', Orphans' and Old Age Contributory Pensions Act, 1936, as if such persons were members of registered friendly societies, subject to such modification in the forms of application for certificates of death required for those purposes as may seem proper to the Registrar-General of Births, Deaths and Marriages for England or for Scotland, as the case may require.
- 6. The requisition to be made to entitle any person to obtain a certified copy of an entry in a register of marriages under the provisions of Section 91 of the Unemployment Insurance Act, 1935, subsection (1) of Section 180 of the National Health Insurance Act, 1936, the last-mentioned subsection as applied by subsection (3) of Section 33 of the Widows'. Orphans' and Old Age Contributory Pensions Act, 1936, and subsection (5) of Section 50 of the Unemployment Act, 1934, shall be in the form C set forth in the schedule to these regulations or a form substantially to the like effect.
- 7. The Certificates of Births, Deaths and Marriages (Requisition) Regulations, 1935,(a) are hereby revoked.
