EXPLANATORY NOTE

O dan Ddeddf Grantiau Tai, Adeiladu ac Adfywio 1996, caiff awdurdod tai lleol gynnig cymorth trwsio cartref ar ffurf naill ai grant neu ddeunydd ar gyfer gwneud gwaith trwsio, gwella neu addasu annedd.

Under the Housing Grants, Construction and Regeneration Act 1996 a local housing authority may provide home repair assistance in the form of a grant or the provision of materials for the carrying out of works of repair, improvement or adaptation to a dwelling.

Er mwyn bod â hawl i gymorth trwsio cartref rhaid i awdurdod tai lleol gael ei fodloni fod yr amodau a nodir yn adran 77(1) o'r Ddeddf yn gymwys. Mae'r rhain yn cynnwys yr amod bod y ceisydd neu bartner y ceisydd yn cael budd-dâl a restrir yn is-adran (1) (e).

For entitlement to home repair assistance a local housing authority has to be satisfied that the conditions set out in section 77(1) of the Act apply. These include the condition that the applicant or the applicant's partner is in receipt of a benefit listed in subsection (1)(e).

Mae'r Rheoliadau hyn yn caniatáu i lwfans ceisio gwaith ar sail incwm gael ei drin fel budd-dâl o fewn yr is-adran honno.

These Regulations enable income-based jobseeker's allowance to be treated as a benefit within that subsection.

Mae'r Rheoliadau hyn yn ymestyn dros Gymru'n unig.

These Regulations extend to Wales only.

The National Assembly for Wales makes the following Regulations in exercise of the powers given to the Secretary of State by section 79 (2) and (3) of the Housing Grants, Construction and Regeneration Act 1996(a), which are now vested in it(b), and of all other powers enabling it in that behalf:

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cymorth Trwsio Cartref (Estyn) (Cymru) 1999 a deuant i rym ar 17 Tachwedd 1999.

1.—(1) These Regulations may be cited as the Home Repair Assistance (Extension) (Wales) Regulations 1999 and shall come into force on 17th November 1999.

(2) Mae'r Rheoliadau hyn yn ymestyn dros Gymru'n unig.

(2) These Regulations extend to Wales only.

2. Estynnir argaeledd cymorth trwsio cartref drwy drin lwfans ceisio gwaith ar sail incwm(c) fel un o'r budd-daliadau a restrir yn is-adran (1)(e) o adran 77 (bod â hawl i gymorth trwsio cartref) o Ddeddf Grantiau Tai, Adeiladu ac Adfywio 1996.

2. The availability of home repair assistance shall be extended by treating income-based jobseeker's allowance(c) as one of the benefits listed in subsection (1)(e) of section 77 (entitlement to home repair assistance) of the Housing Grants, Construction and Regeneration Act 1996.
