Yr oedd yn ofynnol i Gomisiwn Ffiniau Llywodraeth Leol Cymru o dan adran 64(1) o Ddeddf Llywodraeth Leol 1972 (fel y'i hamnewidiwyd gan Ddeddf Llywodraeth Leol (Cymru) 1994) adolygu'r trefniadau etholiadol cyn gynted ag y bo'n ymarferol ar ôl yr etholiadau cyntaf i awdurdodau unedol ym Mai 1995.

The Local Government Boundary Commission for Wales was required by section 64(1) of the Local Government Act 1972 (as substituted by the Local Government (Wales) Act 1994) to review the electoral arrangements as soon as practicable after the first elections to unitary authorities in May 1995.

Mae'r Gorchymyn hwn yn rhoi ei effaith i'r cynigion a wnaed yn adroddiad Mawrth 2001 Comisiwn Ffiniau Llywodraeth Leol Cymru ar gyfer Bwrdeistref Sirol Bro Morgannwg.

This Order gives effect to the proposals made in the Local Government Boundary Commission for Wales' report of March 2001 for the County Borough of the Vale of Glamorgan.

Er bod y Gorchymyn yn diddymu'r holl adrannau etholiadol presennol yn y Fwrdeistref Sirol ac yn eu disodli ag adrannau etholiadol newydd, yn ymarferol bydd y mwyafrif yn aros yr un fath.

Although the Order abolishes all existing electoral divisions within the County Borough and replaces them with new electoral divisions, in practice the majority will remain the same.

Nid oes unrhyw newid i adrannau **Baruc, Buttrills, Cadog, Castleland, Cornerswell, Court, Y Bont-faen, Dinas Powys, Dyfan, Gibbonsdown, Illtud, Llandoche, Llandŵ /Ewenni, Llanilltud Fawr, Llanbedr-y-fro, Y Rhws, Sain Tathan, Saint-y-brid, Stanwell, Gwenfô.**

There is no change to the divisions of **Baruc, Buttrills, Cadoc, Castleland, Cornerswell, Court, Cowbridge, Dinas Powys, Dyfan, Gibbonsdown, Illtyd, Llandough, Llandow/Ewenny, Llantwit Major, Peterston-super-Ely, Rhose, St. Athan, St. Bride's Major, Stanwell, Wenvoe.**

Mae adran etholiadol bresennol Alexandra yn cael ei rhannu i greu dwy adran etholiadol newydd o'r enw **Plymouth a St Augustine's.**

The existing electoral division of Alexandra is divided to create two new electoral divisions called **Plymouth and St. Augustine's.**

Mae adran etholiadol **Plymouth** i gynnwys ward Plymouth cymuned Penarth. Mae'r adran i'w chynrychioli gan ddau gynghorydd.

The electoral division of **Plymouth** is to consist of the Plymouth ward of the community of Penarth. The division to be represented by two councillors.

Mae adran etholiadol **St Augustine's** i gynnwys ward St Augustine's cymuned Penarth. Mae'r adran i'w chynrychioli gan ddau gynghorydd.

Bydd y nifer o gynghorwyr sy'n cynrychioli adran bresennol **Sili** yn cynyddu o un i ddau.

Mae ardaloedd yr adrannau etholiadol newydd wedi'u diffinio ar y map manwl a ddisgrifir yn Erthygl 2. Gellir archwilio printiau ohono ar bob adeg resymol yn swyddfeydd Cyngor Bwrdeistref Sirol Bro Morgannwg ac yn swyddfeydd Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ (Yr Is-adran Moderneiddio Llywodraeth Leol).

The electoral division of **St. Augustine's** is to consist of the St. Augustine's ward of the community of Penarth. The division is to be represented by two councillors.

The number of councillors representing the existing division of **Sully** increases from one to two.

The areas of the new divisions are demarcated on the detailed map described in Article 2, prints of which may be inspected at all reasonable times at the offices of The Vale of Glamorgan County Borough Council and at the offices of the National Assembly for Wales, Cathays Park, Cardiff, CF10 3NQ (Local Government Modernisation Division).

In pursuance of sections 58(1) and 64 of the Local Government Act 1972(a) the Local Government Boundary Commission for Wales submitted proposals in March 2001 for the future electoral arrangements for the County Borough of the Vale of Glamorgan. The National Assembly for Wales having agreed with the proposals makes the following Order in exercise of the powers conferred on it by sections 58(2) and 67(4) and (5) of the Act.

Name, commencement and interpretation

1.-(1) This Order is called The County Borough of The Vale of Glamorgan (Electoral Changes) Order 2002.

(2) This Order will come into force:

(a) for the purposes of proceedings, preliminary or relating to any election to be held on the 6th May 2004, on the 9th October 2003, and

(b) for all other purposes, on 6th May 2004.

(3) In this Order -

"the Act" ("*y Ddeddf*") means the Local Government Act 1972;

"electoral division" ("*adran etholiadol*") means an electoral division of the County Borough of the Vale of Glamorgan constituted by the Vale of Glamorgan Electoral Arrangements Order 1994(b);

Adrannau Etholiadol

2.-(1) Mae adrannau etholiadol presennol Bwrdeistref Sirol Bro Morgannwg a bennir yn yr Atodlen i Orchymyn Trefniadau Etholiadol Bro Morgannwg 1994 yn cael eu diddymu.

(2) At ddibenion ethol cynghorwyr ar gyfer Bwrdeistref Sirol Bro Morgannwg, rhennir y Sir honno yn 23 o adrannau etholiadol yn dwyn yr enwau a bennir yng ngholofn (1) o'r Atodlen i'r Gorchymyn hwn, a bydd pob adran etholiadol o'r fath yn ffurfio'r ardal a bennir yng ngholofn (2) o'r Atodlen honno, fel y'i dynodir ar y map ac fel y'i diffinnir â llinellau coch.

(3) Y nifer o gynghorwyr sydd i'w hethol ar gyfer pob adran etholiadol o'r fath fydd y nifer a bennir mewn perthynas â'r adran yng ngholofn (3) o'r Atodlen i'r Gorchymyn hwn.

Y Gofrestr o Etholwyr Llywodraeth Leol

3. Bydd y swyddog cofrestru yn gwneud unrhyw addrefniadau neu addasiadau i'r gofrestr o etholwyr llywodraeth leol sy'n angenrheidiol am fod y Gorchymyn hwn yn dod i rym.

"map" ("*map*") means the map marked "map of the County Borough of the Vale of Glamorgan (Electoral Changes) Order 2002" and deposited in accordance with Regulation 5 of the Local Government Area Changes Regulations 1976(a).

Electoral Divisions

2.-(1) The existing electoral divisions of the County Borough of the Vale of Glamorgan specified in the Schedule to the County Borough of the Vale of Glamorgan Electoral Arrangements Order 1994 are abolished.

(2) For the purposes of the elections of councillors for the County Borough of the Vale of Glamorgan, that County shall be divided into 23 electoral divisions bearing the names specified in column (1) of the Schedule to this Order, and each such electoral division is to comprise the area specified in column (2) of that Schedule, as designated on the map and demarcated by red lines.

(3) The number of councillors to be returned for each such electoral division is to be the number specified in relation to the division in column (3) of the Schedule to this Order.

Register of Local Government Electors

3. The registration officer will make such re-arrangements or adaptation of the register of local government electors as may be necessary due to the coming into force of this Order.

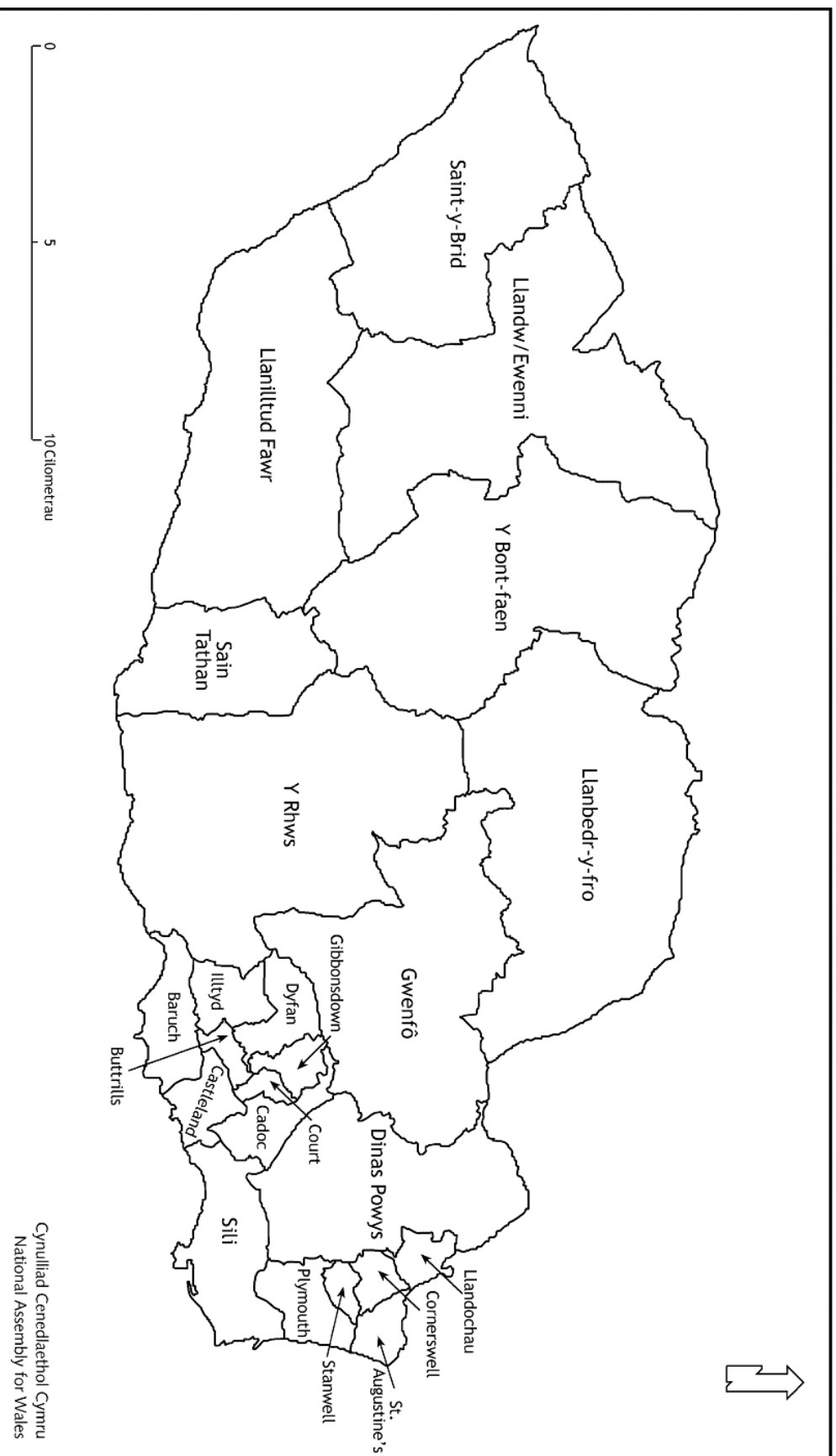

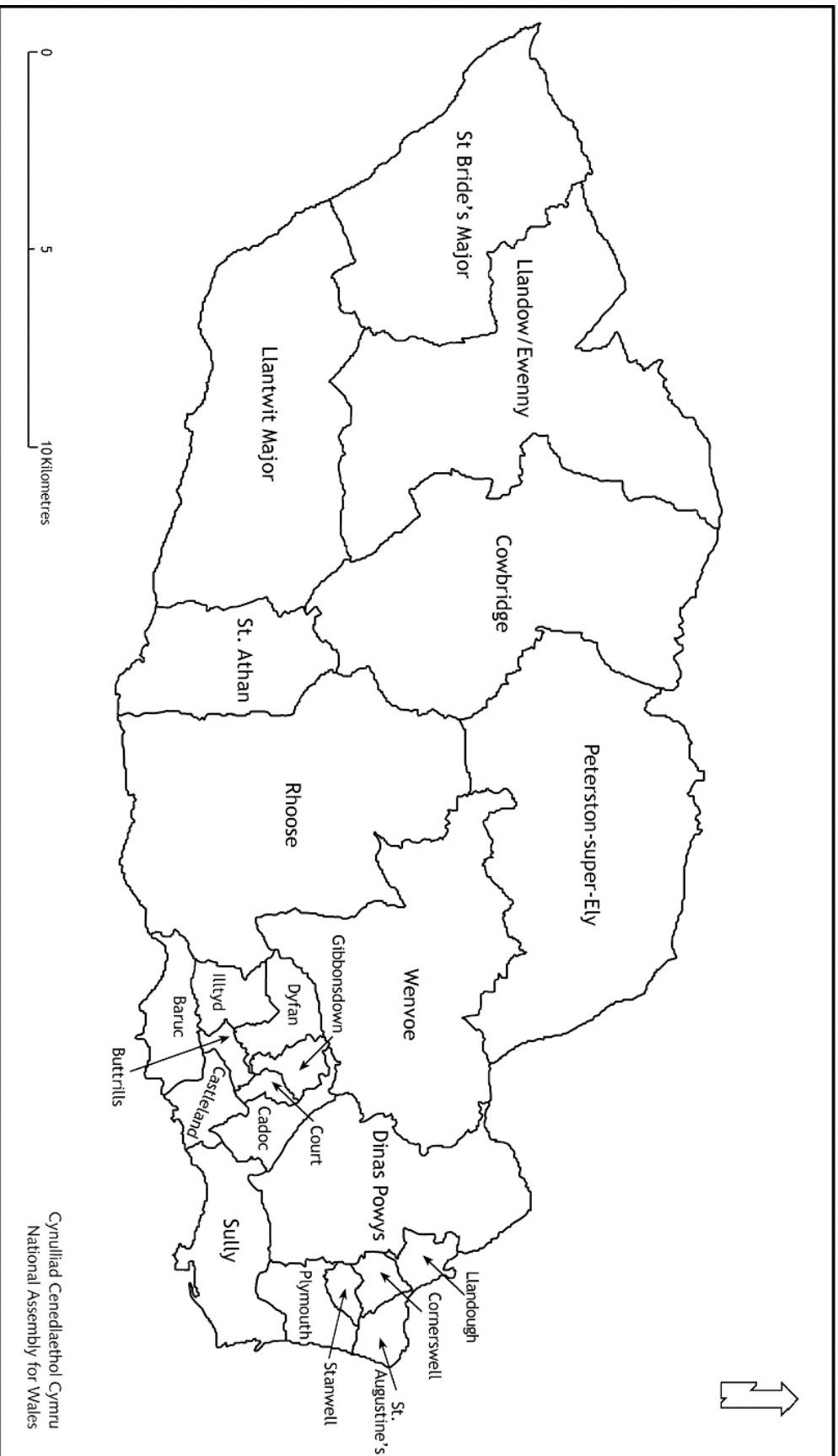
