Mae'r Gorchymyn hwn yn rhoi ei effaith i'r cynigion a wnaed yn adroddiad Comisiwn Ffiniau Llywodraeth Leol Cymru yn Rhagfyr 1999 ar gyfer Sir Ceredigion.

Er bod y Gorchymyn yn diddymu'r holl adrannau etholiadol presennol yn y Sir ac yn eu disodli ag adrannau etholiadol newydd, yn ymarferol bydd y mwyafriol yn aros yr un fath.

Nid oes unrhyw newid i adrannau **Aberaeron, Aberporth, Beulah, Capel Dewi, Ceinewydd, Ceulan-a-Maesmor, Ciliau Aeron, Faenor, Llanbedr Pont Steffan, Llandyfrög, Llandysiliogogo, Llanfarian, Llanfihangel Ystrad, Llangeitho, Llangybi, Llannarth, Llanrhystud, Llansanffraid, Llanwenog, Lledrod, Melindwr, Penbryn, Pen-parc, Tirymynach, Trefeurig, Tref Llandysul, Tregaron, Troed-yr-aur, Y Borth, Ystwyth.**

### EXPLANATORY NOTE

*(This note is not part of the Order)*

The Local Government Boundary Commission for Wales was required by section 64(1) of the Local Government Act 1972 (as substituted by the Local Government (Wales) Act 1994) to review electoral arrangements as soon as practicable after the first elections to unitary authorities in May 1995.

This Order gives effect to the proposals made in the Local Government Boundary Commission for Wales' report of December 1999 for the County of Ceredigion.

Although the Order abolishes all existing electoral divisions within the County and replaces them with new electoral divisions, in practice the majority will remain the same.

There is no change to the divisions of **Aberaeron, Aberporth, Beulah, Borth, Capel Dewi, Ceulanamaesmawr, Ciliau Aeron, Faenor, Lampeter, Llanarth, Llandyfrög, Llandysiliogogo, Llandysul Town, Llanfarian, Llanfihangel Ystrad, Llangeitho, Llangybi, Llanrhystyd, Llansantffraed, Llanwenog, Lledrod, Melindwr, New Quay, Penbryn, Penparc, Tirymynach, Trefeurig, Tregaron, Troedyraur, Ystwyth.**

The following changes are made by this Order:

Aberystwyth is divided into five electoral divisions:

**Aberystwyth Canol/Central** consisting of the Central ward of the community of Aberystwyth, returning one councillor;

**Aberteifi/Cardigan - Rhyd-y-fuwch**, yn cynnwys ward Rhyd-y-fuwch cymuned Aberteifi;

**Aberteifi/Cardigan - Teifi** yn cynnwys ward Teifi cymuned Aberteifi.

Rhennir Aberystwyth yn bum adran etholiadol:

**Aberystwyth Bronglais** yn cynnwys Ward Ddwyreiniol cymuned Aberystwyth, sy'n ethol un cyngphonydd;

**Aberystwyth Canol/Central** yn cynnwys ward Ganolog cymuned Aberystwyth, sy'n ethol un cyngphonydd;

**Aberystwyth Gogledd/North** yn cynnwys ward Ogledol cymuned Aberystwyth sy'n ethol un cyngphonydd;

**Aberystwyth Penparcau** yn cynnwys ward Ddeheuol cymuned Aberystwyth, sy'n ethol dau gynghorydd; ac

**Aberystwyth Rheidol** yn cynnwys ward Glanyrafon cymuned Aberystwyth, sy'n ethol un cyngphonydd.

Rhennir adran bresennol **Llanbadarn Fawr** er mwyn creu dwy adran etholiadol o'r enw

**Llanbadarn Fawr Sulien a Llanbadarn Fawr Padarn** - y naill a'r llall yn ethol un cyngphonydd.

Mae ardaloedd yr adrannau etholiadol newydd wedi'u diffinio ar y mapiau manwl a ddisgrifir yn Erthygl 2. Gellir archwilio printiau ohonynt ar bob adeg resymol yn swyddfeydd Cyngor Sir Ceredigion ac yn swyddfeydd Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ (Yr Is-adran Moderneiddio Llywodraeth Leol).

**Aberystwyth Bronglais** consisting of the East Ward of the community of Aberystwyth, returning one councillor;

**Aberystwyth Gogledd/North** consisting of the North ward of the community of Aberystwyth, returning one councillor.

**Aberystwyth Rheidol** consisting of the Riverside ward of the community of Aberystwyth, returning one councillor;

**Aberystwyth Penparcau** consisting of the South ward of the community of Aberystwyth, returning two councillors.

The existing division of **Cardigan** is divided into three new electoral divisions:

**Aberteifi/Cardigan - Teifi** consisting of the Teifi ward of the community of Cardigan;

**Aberteifi/Cardigan - Rhyd-y-Fuwch**, consisting of the Rhyd-y-Fuwch ward of the community of Cardigan; and

**Aberteifi/Cardigan - Mwldan**, consisting of the Mwldan ward of the community of Cardigan. Each new electoral division to be represented by one councillor.

The existing division of **Llanbadarn Fawr** is divided to create two electoral divisions named **Llanbadarn Fawr Sulien** and **Llanbadarn Fawr Padarn** - each returning one councillor.

The areas of the new divisions are demarcated on the detailed maps described in Article 2, prints of which may be inspected at all reasonable times at the offices of Ceredigion County Council and at the offices of the National Assembly for Wales, Cathays Park, Cardiff, CF10 3NQ (Local Government Modernisation Division).

In pursuance of sections 58(1) and 64 of the Local Government Act 1972(a) the Local Government Boundary Commission for Wales submitted proposals in December 1999 for the future electoral arrangements for the County of Ceredigion. The National Assembly for Wales having agreed with the proposals makes the following Order in exercise of the powers conferred on it by sections 58(2) and 67(4) and (5) of the Act.

**Name, commencement and interpretation**

**1.-(1)** This Order is called the County of Ceredigion (Electoral Changes) Order 2002.

(2) This Order will come into force:

(a) for the purposes of proceedings, preliminary or relating to any election to be held on the 6th May 2004, on the 9th October 2003, and

(b) for all other purposes, on 6th May 2004.

(3) In this Order -

"the Act" ("y Ddeddf") means the Local Government Act 1972;

"electoral division" ("adran etholiadol") means an electoral division of the County of Ceredigion as constituted by the County of Cardiganshire Electoral Arrangements Order 1994(b).

"map C" ("map C") means the map prepared by the National Assembly for Wales and marked "map C of the Community of Llanbadarn Fawr Electoral Divisions Order 2002" and deposited in accordance with Regulation 5 of the Local Government Area Changes Regulations 1976.

## Adrannau etholiadol

2.-(1) Mae adrannau etholiadol presennol Sir Ceredigion a bennir yn yr Atodlen i Orchymyn Trefniadau Etholiadol Sir Aberteifi 1994 wedi'u diddymu.

(2) At ddibenion ethol cyngorwyr ar gyfer Sir Ceredigion, rhennir y Sir honno yn 40 o adrannau etholiadol yn dwyn yr enwau a bennir yng ngholofn (1) o'r Atodlen i'r Gorchymyn hwn, a bydd pob adran etholiadol o'r fath yn ffurffio'r ardal a bennir yng ngholofn (2) o'r Atodlen honno, fel y'i dynodir ar y mapiau ac fel y'i diffinnir â llinellau coch.

(3) Y nifer a bennir mewn perthynas â'r adran yng ngholofn (3) o'r Atodlen i'r Gorchymyn hwn fydd y nifer o gynghorwyr sydd i'w hethol ar gyfer pob adran etholiadol o'r fath.

## Y Gofrestr o Etholwyr Llywodraeth Leol

3. Rhaid i'r swyddog cofrestru wneud unrhyw adrefniadau neu addasiadau i'r gofrestr o etholwyr llywodraeth leol sy'n angenrheidiol am fod y Gorchymyn hwn yn dod i rym.

## Electoral Divisions

2.-(1) The existing electoral divisions of the County of Ceredigion specified in the Schedule to the County of Cardiganshire Electoral Arrangements Order 1994 are abolished.

(2) For the purposes of the elections of councillors for the County of Ceredigion, that County shall be divided into 40 electoral divisions bearing the names specified in column (1) of the Schedule to this order, and each such electoral division shall comprise the area specified in column (2) of that Schedule, as designated on the maps and demarcated by red lines.

(3) The number of councillors to be returned for each such electoral division shall be the number specified in relation to the division in column (3) of the Schedule to this Order.

## Register of Local Government Electors

3. The registration officer shall make such rearrangements or adaptation of the register of local government electors as may be necessary due to the coming into force of this Order.





## **Map A Gorchymyn Cymuned Aberystwyth (Adrannau Etholiadol) 2002**





## **Map A of the Community of Aberystwyth (Electoral Divisions) Order 2002**





## Map B Gorchymyn Cymuned Aberteifi (Adrannau Etholiadol) 2002






