O dan adran 64(1) o Ddeddf Llywodraeth Leol 1972 (fel y'i hamnewidwyd gan Ddeddf Llywodraeth Leol (Cymru) 1994) yr oedd yn ofynnol i Gomisiwn Ffiniau Llywodraeth Leol Cymru adolygu'r trefniadau etholiadol cyn gynted â phosibl ar ôl yr etholiadau cyntaf i'r awdurdodau unedol ym Mai 1995.

Mae'r Gorchymyn hwn yn rhoi eiu heffaith (gyda rhai addasiadau) i'r cynigion a wnaed yn adroddiad Comisiwn Ffiniau Llywodraeth Leol Cymru yn Hydref 1999 ar gyfer Bwrdeistref Sirol Torfaen.

Er bod y Gorchymyn yn diddymu'r holl adrannau etholiadol presennol yn y Fwrdeistref Sirol ac yn eu disodli ag adrannau etholiadol newydd, yn ymarferol bydd y mwyafrif yn aros yr un fath.

Nid oes unrhyw newid i adrannau **Abersychan**, **Blaenafon**, **Brynwern**, **Coed Efa**, **Gogledd Croesyceiliog**, **De Croesyceiliog**, **Cwmwynsgoi**, Fairwater, Greenmeadow, Llantarnam, Gogledd **Llanyrafon**, **De Llanyrafon**, Pant-eg, Pontnewydd, Pontnewynydd, Pont-y-pŵl, Snatchwood, St Cadocs a Phen-y-garn, Llanfihangel Llantarnam, Trefddyn, Two Locks, Cwmbrân, Waunfelin.

Er hymny bydd adrannau presennol New Inn Isaf a New Inn Uchaf yn cael eu cyfuno i ffurfio etholaeth adran etholiadol **New Inn**. Bydd yn cynnwys Cymuned New Inn ac yn cael ei chynrychioli gan dri chyngorydd.

The County Borough of Torfaen (Electoral Changes) Order 2002

EXPLANATORY NOTE

(This note is not part of the Order)

The Local Government Boundary Commission for Wales was required by section 64(1) of the Local Government Act 1972 (as substituted by the Local Government (Wales) Act 1994) to review electoral arrangements as soon as possible after the first elections to unitary authorities in May 1995.

This Order gives effect (with some modifications) to the proposals made in the Local Government Boundary Commission for Wales' report of October 1999 for the County Borough of Torfaen.

Although the Order abolishes all existing electoral divisions within the County Borough and replaces them with new electoral divisions, in practice the majority will remain the same.

There is no change to the divisions of **Abersychan**, **Blaenavon**, **Brynwern**, **Coed Eva**, **Croesyceiliog North**, **Croesyceiliog South**, **Cwmwyniscoy**, Fairwater, Greenmeadow, Llantarnam, Llanyrafon North, Llanyrafon South, Panteg, Pontnewydd, Pontnewynydd, Pontypool, Snatchwood, St. Cadocs and Penygarn, St. Dials, Trevethin, Two Locks, Upper Cwmbrân, Wainfelin.

The existing divisions of New Inn Lower and New Inn Upper however shall be combined to form the electoral division of **New Inn**. It will consist of the Community of New Inn and be represented by three councillors.

Yn unol ag adrannau 58(1) a 64 o Ddeddf Llywodraeth Leol 1972(a) cyflwynodd Comisiwn Ffiniau Llywodraeth Leol Cymru gynigion yn Rhagfyr 1999 ar gyfer trefniadau etholiadol y dyfodol ar gyfer Bwrdeistref Sirol Torfaen. Mae Cynulliad Cenedlaethol Cymru, gan ei fod wedi cytuno â'r cynigion (gyda rhai addasiadau) yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd iddo gan adrannau 58(2) a 67(4) a (5) o'r Ddeddf.

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Bwrdeistref Sirol Torfaen (Newidiadau Etholiadol) 2002.

(2) Daw'r Gorchymyn hwn i rym:

(a) at ddibenion achosion, sy'n arwain at unrhyw etholiad neu'n ymwneud ag unrhyw etholiad sydd i'w gynnal ar 6 Mai 2004, ar 9 Hydref 2003, a

(b) at bob diben arall, ar 6 Mai 2004.

(3) Yn y Gorchymyn hwn -

ystyr "y Ddeddf" ("the Act") yw Deddf Llywodraeth Leol 1972;

ystyr "adran etholiadol" ("electoral division") yw un o adrannau etholiadol Bwrdeistref Sirol Torfaen fel y'i sefydlwyd gan Orchymyn Trefniadau Etholiadol Bwrdeistref Sirol Torfaen 1994(b);

In pursuance of sections 58(1) and 64 of the Local Government Act 1972(a) the Local Government Boundary Commission for Wales submitted proposals in December 1999 for the future electoral arrangements for the County Borough of Torfaen. The National Assembly for Wales having agreed with the proposals (with some modifications) makes the following Order in exercise of the powers conferred on it by sections 58(2) and 67(4) and (5) of the Act.

Name, commencement and interpretation

1.-(1) This Order is called the County Borough of Torfaen (Electoral Changes) Order 2002.

(2) This Order will come into force:

(a) for the purposes of proceedings, preliminary or relating to any election to be held on 6th May 2004, on the 9th October 2003, and

(b) for all other purposes, on 6th May 2004.

(3) In this Order -

"the Act" ("y Ddeddf") means the Local Government Act 1972;

"electoral division" ("adran etholiadol") means an electoral division of the County Borough of Torfaen as constituted by the County Borough of Torfaen Electoral Arrangements Order 1994(b);

(b) This Order was made on the 19th December 1994 by the Secretary of State for the Home Department.

Adrannau etholiadol

2.-(1) Mae adrannau etholiadol presennol Bwrdeistref Sirol Tor-faen a bennir yn yr Atodlen i Orchymyn Trefniadau Etholiadol Bwrdeistref Sirol Tor-faen 1994 wedi'u diddymu.

(2) At ddibenion ethol cynghorwyr ar gyfer Bwrdeistref Sirol Tor-faen, rhennir y fwrdeistref sirol honno yn 24 o adrannau etholiadol yn dwyn yr enwau a bennir yng ngholofn (1) o'r Atodlen i'r Gorchymyn hwn, a bydd pob adran etholiadol o'r fath yn ffurfio'r ardal a bennir yng ngholofn (2) o'r Atodlen honno.

(3) Y nifer a bennir mewn perthynas â'r adran yng ngholofn (3) o'r Atodlen i'r Gorchymyn hwn fydd y nifer o gynghorwyr sydd i'w hethol ar gyfer pob adran etholiadol o'r fath.

Y Gofrestr o Etholwyr Llywodraeth Leol

3. Rhaid i'r swyddog cofrestru wneud unrhyw ad-drefniadau neu addasiadau i'r gofrestr o etholwyr llywodraeth leol sy'n angenrheidiol am fod y Gorchymyn hwn yn dod i rym.

Electoral Divisions

2.-(1) The existing electoral divisions of the County Borough of Torfaen specified in the Schedule to the County Borough of Torfaen Electoral Arrangements Order 1994 are abolished.

(2) For the purposes of the elections of councillors for the county borough of Torfaen, that county borough shall be divided into 24 electoral divisions bearing the names specified in column (1) of the Schedule to this Order, and each such electoral division shall comprise the area specified in column (2) of that Schedule.

(3) The number of councillors to be returned for each such electoral division shall be the number specified in relation to the division in column (3) of the Schedule to this Order.

Register of Local Government Electors

3. The registration officer shall make such re-arrangements or adaptation of the register of local government electors as may be necessary due to the coming into force of this Order.
