EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn dirymu a disodli Rheoliadau Addysg (Y Diwrnod Ysgol a'r Flwyddyn Ysgol) (Cymru) 2000 fel y'i diwygiwyd.

These Regulations revoke and replace the Education (School Day and School Year) (Wales) Regulations 2000, as amended.

Mae Rheoliad 4 yn gwneud darpariaeth ynghylch hyd y diwrnod ysgol a'r flwyddyn ysgol.

Regulation 4 makes provision about the length of the school day and the school year.

Mae Rheoliad 5 yn darparu na cheir trin mwy na dwy sesiwn ysgol a neilltuwyd ar gyfer hyfforddi athrawon mewn datblygu trefniadau ar gyfer derbyn disgyblion i'r cyfnod allweddol cyntaf a throsi rhwng y cyfnodau allweddol ac ar gyfer cynllunio a chyflwyno'r cwricwlwm ym mhob un o'r blynyddoedd ysgol 2003-2004, 2004-2005 a 2005-2006 fel sesiynau pan gyfarfu'r ysgol.

Regulation 5 provides that not more than two school sessions devoted to the training of teachers in the development of arrangements for entry of pupils into the first key stage and transition between the key stages and for the planning and delivery of the curriculum in each of the 2003-2004, 2004-2005 and 2005-2006 school years may be treated as sessions on which the school has met.

Drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 551 a 569(4) a (5) o Ddeddf Addysg 1996(a) ac sydd wedi'u breinio bellach yng Nghynulliad Cenedlaethol Cymru(b), mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol:

In exercise of the powers conferred on the Secretary of State by sections 551 and 569(4) and (5) of the Education Act 1996(a) and now vested in the National Assembly for Wales(b), the National Assembly for Wales makes the following Regulations:

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Y Diwrnod Ysgol a'r Flwyddyn Ysgol) (Cymru) 2003 a deuant i rym ar 31 Rhagfyr 2003.

1.-(1) These Regulations are called the Education (School Day and School Year) (Wales) Regulations 2003 and come into force on 31st December 2003.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig.

(2) These Regulations apply only to Wales.

Dehongli

3. Yn y Rheoliadau hyn -

ystyr "dosbarth meithrin" ("*nursery class*") yw dosbarth sydd wrthi'n bennaf yn darparu addysg lawnamser neu ran-amser sydd yn addas ar gyfer plant nad ydynt wedi cyrraedd oedran ysgol orfodol;

ystyr "y flwyddyn ysgol" ("*school year*") yw'r cyfnod sy'n dechrau gyda'r tymor ysgol cyntaf i ddechrau ar ôl Gorffennaf ac sy'n diweddu gyda dechrau'r tymor ysgol cyntaf sy'n dechrau ar ôl y Gorffennaf canlynol; ac

ystyr "ysgol" ("*school*") yw ysgol a gynhelir gan awdurdod addysg lleol, neu ysgol arbennig nad yw awdurdod addysg lleol yn ei chynnal.

Sesiynau ysgol

4.-(1) Yn ddarostyngedig i baragraff (6), rhennir pob diwrnod y mae ysgol yn cyfarfod yn ddwy sesiwn a wahanir gan egwyl yng nghanol y dydd oni bai bod amgylchiadau eithriadol yn peri nad yw hyn yn ddymunol.

(2) Rhaid cynnal o leiaf 380 o sesiynau mewn ysgol yn ystod unrhyw flwyddyn ysgol ond er hynny nid oes dim yn y paragraff hwn sy'n ei gwneud yn ofynnol i ddosbarth meithrin gyfarfod am y nifer hwnnw o sesiynau.

(3) Pan rwystrir ysgol ar unrhyw adeg rhag cyfarfod am un neu fwy o sesiynau y bwriadwyd iddi gyfarfod, ac nad yw'n rhesymol ymarferol gwneud trefniadau iddi gyfarfod ar adeg wahanol ar gyfer y sesiynau hynny, ymdrinnir â'r ysgol at ddiibenion paragraff (2) fel pe bai wedi cyfarfod yn unol â'r bwriad.

(4) Yn ddarostyngedig i baragraff (5), ar bob diwrnod y bydd ysgol feithrin neu ddosbarth meithrin yn cyfarfod rhaid darparu o leiaf deirawr o weithgareddau addas.

(5) Mae'n ddigonol darparu gweithgareddau addas am awr a hanner i ddisgybl ar ddiwrnod pan fydd y disgybl -

- (a) yn bresennol mewn ysgol feithrin neu ddosbarth meithrin sy'n cyfarfod am un sesiwn yn unig; neu
- (b) yn bresennol mewn ysgol feithrin neu ddosbarth meithrin am un sesiwn yn unig allan o ddwy sesiwn.

Interpretation

3. In these Regulations -

"nursery class" ("*dosbarth meithrin*") means a class predominantly engaged in the provision of full-time or part-time education suitable for children who have not attained compulsory school age;

"school" ("*ysgol*") means a school maintained by a local education authority, or a special school not maintained by a local education authority; and

"school year" ("*y flwyddyn ysgol*") means the period beginning with the first school term to begin after July and ending with the beginning of the first such term to begin after the following July.

School sessions

4.-(1) Subject to paragraph (6), every day on which a school meets is to be divided into two sessions which are to be separated by a break in the middle of the day unless exceptional circumstances make this undesirable.

(2) At least 380 sessions must be held at a school during any school year save that nothing in this paragraph is to require a nursery class to meet for that number of sessions.

(3) Where at any time a school is prevented from meeting for one or more sessions for which it was intended that it should meet, and it is not reasonably practicable for arrangements to be made for it to meet at an alternative time for those sessions, the school is to be treated for the purposes of paragraph (2) as if it had met as intended.

(4) Subject to paragraph (5), on every day on which a nursery school or nursery class meets there must be provided at least three hours of suitable activities.

(5) On a day on which a pupil -

- (a) attends a nursery school or nursery class which meets for only a single session; or
- (b) attends a nursery school or nursery class for one only of two sessions, it is sufficient to provide the pupil with one and a half hours of suitable activities.

(6) Mewn ysgol sy'n cyfarfod ar chwe diwrnod o'r wythnos gall fod un sesiwn yn unig ar ddau o'r dyddiau hynny.

5.-(1) Pan fydd sesiwn ysgol yn y flwyddyn ysgol 2003-2004 wedi'i neilltuo'n llwyr neu yn bennaf i ddarparu hyfforddiant y mae'r paragraff hwn yn gymwys iddo ar gyfer athrawon a gyflogir yn yr ysgol honno, ymdrinnir â'r sesiwn honno at ddibenion rheoliad 4 fel pe bai'n sesiwn pan gyfarfu'r ysgol.

(2) Pan fydd sesiwn ysgol yn y flwyddyn ysgol 2004-2005 wedi'i neilltuo'n llwyr neu yn bennaf i ddarparu hyfforddiant y mae'r paragraff hwn yn gymwys iddo ar gyfer athrawon a gyflogir yn yr ysgol honno, ymdrinnir â'r sesiwn honno at ddibenion rheoliad 4 fel pe bai'n sesiwn pan gyfarfu'r ysgol.

(3) Pan fydd sesiwn ysgol yn y flwyddyn ysgol 2005-2006 wedi'i neilltuo'n llwyr neu yn bennaf i ddarparu hyfforddiant y mae'r paragraff hwn yn gymwys iddo ar gyfer athrawon a gyflogir yn yr ysgol honno, ymdrinnir â'r sesiwn honno at ddibenion rheoliad 4 fel pe bai'n sesiwn pan gyfarfu'r ysgol.

(4) Nid yw paragraff (1) yn gymwys ond mewn perthynas â sesiynau ar neu ar ôl 1 Ionawr 2004 ac nid oes dim ym mharagraffau (1), (2) a (3) i fod yn effeithiol mewn perthynas â mwy na dwy sesiwn ysgol ym mhob blwyddyn ysgol.

(5) Mae paragraff (1) yn gymwys i hyfforddiant sy'n ymwneud â datblygu trefniadau ar gyfer derbyn disgyblion i'r cyfnod allweddol cyntaf a throsi rhwng y cyfnodau allweddol ac ar gyfer cynllunio a chyflwyno'r cwricwlwm.

(6) In a school which meets on six days a week there may on two of those days be only a single session.

5.-(1) Where a school session in the 2003-2004 school year is devoted wholly or mainly to the provision to teachers employed at that school of training to which this paragraph applies, that session is to be regarded for the purposes of regulation 4 as a session on which that school has met.

(2) Where a school session in the 2004-2005 school year is devoted wholly or mainly to the provision to teachers employed at that school of training to which this paragraph applies, that session is to be regarded for the purposes of regulation 4 as a session on which that school has met.

(3) Where a school session in the 2005-2006 school year is devoted wholly or mainly to the provision to teachers employed at that school of training to which this paragraph applies, that session is to be regarded for the purposes of regulation 4 as a session on which that school has met.

(4) Paragraph (1) is only to apply in relation to sessions on or after 1st January 2004 and none of paragraphs (1), (2) and (3) is to have effect in relation to more than two school sessions in each school year.

(5) Paragraph (1) applies to training relating to the development of arrangements for entry of pupils into the first key stage and transition between the key stages and for the planning and delivery of the curriculum.
