The National Council for Education and Training for Wales (Transfer of Functions to the National Assembly for Wales and Abolition) Order 2005

EXPLANATORY NOTE

(This note is not part of the Order)

Section 28 of the Government of Wales Act 1998 gives the National Assembly for Wales ("the National Assembly") powers with respect to the structure of certain public bodies in Wales listed in Schedule 4 to that Act.

It provides that the National Assembly may transfer the functions of some of those bodies to another such body, to a Welsh local authority or to itself; and that it may abolish such bodies where all their functions have been transferred.

This Order transfers the functions of the National Council for Education and Training for Wales ("the Council") to the National Assembly, provides for the transfer of staff from the Council to the National Assembly and makes appropriate consequential, incidental, transitional and supplementary provisions.

Article 2 provides for the transfer of the Council's functions to the National Assembly.

Article 3 provides for the transfer of the Council's staff and applies the Transfer of Undertakings (Protection of Employment) Regulations 1981.

Article 4 provides for the transfer of property, rights and liabilities.

Article 5 provides for continuity in the exercise of functions.

Mae erthyglau 7 ac 8 yn gwneud darpariaethau trosiannol penodol gan gynnwys mewn perthynas â pharatoi cyfrifon ar gyfer y Cyngor gan y Cynulliad Cenedlaethol ar gyfer y flwyddyn ariannol 2005 - 2006.

Mae erthygl 9 yn darparu ar gyfer diwygiadau canlyniadol i ddeddfwriaeth sylfaenol ac is-deddfwriaeth.

Mae arfarniad rheoliadol wedi'i baratoi a gellir cael copïau gan Gynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd.

Article 6 provides that upon the transfer of the functions, the Council is abolished.

Articles 7 and 8 make certain transitional provisions including in relation to the preparation by the National Assembly of accounts for the Council for the financial year 2005- 2006.

Article 9 provides for consequential amendments to primary and subordinate legislation.

A regulatory appraisal has been prepared and copies are available from the National Assembly for Wales, Cathays Park, Cardiff.

The National Assembly for Wales, in accordance with
the powers conferred upon it by section 28 of and
Schedule 4 to the Government of Wales Act 1998(1),
makes the following Order:

Title, commencement and interpretation

1.-(1) This Order is called the National Council for
Education and Training for Wales (Transfer of
Functions to the National Assembly for Wales and
Abolition) Order 2005 and comes into force on 1 April
2006.

(2) In this Order:

"the Council" ("y Cyngor") means the National
Council for Education and Training for Wales;

"the National Assembly" ("y Cynulliad
Cenedlaethol") means the National Assembly for
Wales;

"transfer date" ("dyddiad trosglwyddo") means 1
April 2006.

**Transfer of Functions of the Council to the
National Assembly**

2. Subject to article 9, on the transfer date all the
functions of the Council are transferred to the National
Assembly.

Trosglwyddo staff

3. At ddibenion Rheoliadau Trosglwyddo Ymgymeriadau (Diogelu Cyflogaeth) 1981(1)-

- (a) mae'r trosglwyddiad swyddogaethau y mae erthygl 2 yn ei wneud yn effeithiol i'w drin fel pe bai'n drosglwyddiad ymgymeriad;
- (b) mae pob person a oedd, yn union cyn y dyddiad trosglwyddo, yn gyflogedig gan y Cyngor o dan gcontract cyflogaeth, i'w drin fel pe bai'n gyflogedig yn yr ymgymeriad yn union cyn y dyddiad trosglwyddo.

Trosglwyddo eiddo, hawliau a rhwymedigaethau

4.-(1) Ar y dyddiad trosglwyddo, trosglwyddir yr holl eiddo, hawliau a rhwymedigaethau yr oedd gan y Cyngor hawl iddynt neu yr oedd y Cyngor yn ddarostyngedig iddynt yn union cyn y dyddiad trosglwyddo i'r Cynulliad Cenedlaethol.

(2) Bydd dystysgrif a ddyroddir gan y Cynulliad Cenedlaethol bod unrhyw eiddo, hawliau neu rhwymedigaethau wedi'u trosglwyddo gan baragraff (1) yn dystiolaeth ddigamsyniol o'r trosglwyddiad.

(3) Nid yw'r cyfeiriad ym mharagraff (1) at hawliau a rhwymedigaethau yn cynnwys hawliau a rhwymedigaethau o dan gcontract cyflogaeth a drosglwyddir yn rhinwedd erthygl 3.

(4) Mae i baragraff (1) effaith mewn cysylltiad ag eiddo, hawliau a rhwymedigaethau-

- (a) er gwaethaf unrhyw ddarpariaeth (o ba natur bynnag) a fyddai fel arall yn rhwystro eu trosglwyddo, neu'n ei gosbi, neu'n cyfyngu ar eu trosglwyddo ac eithrio drwy'r gorchymyn hwn;
- (b) heb fod unrhyw offeryn neu ffurfioldeb arall yn ofynnol.

Darpariaeth ar gyfer parhad o ran arfer swyddogaethau

5. I'r graddau y mae'n ofynnol ar gyfer parhau ei effaith ar ac ar ôl y dyddiad trosglwyddo, rhaid i unrhyw beth a wnaed gan y Cyngor neu mewn perthynas ag ef ac sy'n cael effaith yn union cyn y dyddiad trosglwyddo, gael effaith fel pe bai wedi'i wneud gan y Cynulliad Cenedlaethol neu mewn perthynas â'r Cynulliad Cenedlaethol.

Diddymu'r Cyngor

6. Ar y dyddiad trosglwyddo mae'r Cyngor yn peidio â bod.

Transfer of staff

3. For the purposes of the Transfer of Undertaking (Protection of Employment) Regulations 1981(1)-

- (a) the transfer of functions effected by article 2 is to be treated as a transfer of an undertaking;
- (b) each person who was, immediately before the transfer date, employed by the Council under a contract of employment is to be treated as employed in the undertaking immediately before the transfer date.

Transfer of property, rights and liabilities

4.-(1) On the transfer date, all property, rights and liabilities to which the Council was entitled or subject immediately before the transfer date are transferred to the National Assembly.

(2) A certificate issued by the National Assembly that any property, rights or liabilities has been transferred by paragraph (1) shall be conclusive evidence of the transfer.

(3) The reference in paragraph (1) to rights and liabilities does not include rights and liabilities under a contract of employment transferred by virtue of article 3.

(4) Paragraph (1) has effect in relation to property, rights and liabilities-

- (a) despite any provision (of whatever nature) which would otherwise prevent, penalise or restrict their transfer otherwise than by this order;
- (b) without any instrument or other formality being required.

Provision for continuity in the exercise of functions

5. Anything done by or in relation to the Council which has effect immediately before the transfer date shall so far as it is required for continuing its effect on and after the transfer date have effect as if done by or in relation to the National Assembly.

Abolition of the Council

6. On the transfer date the Council ceases to exist.

7.-(1) Nid oes dim yn y Gorchymyn hwn yn effeithio ar ddilysrwydd unrhyw beth a wneir gan y Cyngor neu mewn perthynas ag ef cyn y dyddiad trosglwyddo.

(2) Caniateir i'r Cynulliad Cenedlaethol barhau, neu caniateir parhau, mewn perthynas â'r Cynulliad Cenedlaethol, ag unrhyw beth (gan gynnwys achosion cyfreithiol) sydd yn y broses o gael ei wneud gan y Cyngor neu mewn perthynas ag ef cyn y dyddiad trosglwyddo.

(3) Ar neu ar ôl y dyddiad trosglwyddo, i'r graddau y bo'n angenrheidiol neu'n briodol, mae cyfeiriadau at y Cyngor, mewn unrhyw offerynnau, contractau, neu achosion cyfreithiol, i'w trin fel pe baent yn gyfeiriadau at y Cynulliad Cenedlaethol.

Cyfrifon

8.-(1) Rhaid i'r Cynulliad Cenedlaethol-

- (a) paratoi datganiad o gyfrifon ar gyfer y cyfnod sy'n cychwyn ar ddyddiad y datganiad diwethaf o gyfrifon a baratowyd gan y Cyngor ac sy'n gorffen ar y dyddiad trosglwyddo;
 - (b) anfon copi o'r datganiad at Archwilydd Cyffredinol Cymru cyn diwedd y cyfnod o 6 mis yn cychwyn ar y dyddiad trosglwyddo.
- (2) Rhaid i Archwilydd Cyffredinol Cymru-
- (a) archwilio ac ardystio'r datganiad y mae wedi'i dderbyn o dan yr erthygl hon a llunio adroddiad arno;
 - (b) gosod copi o'r adroddiad ar y datganiad gerbron y Cynulliad Cenedlaethol.

9.-(1) Diwygir y Deddfau a bennir yn Atodlen 1 yn unol â'r Atodlen honno.

Transitional Provisions

7.-(1) Nothing in this Order affects the validity of anything done by or in relation to the Council before the transfer date.

(2) There may be continued by or in relation to the National Assembly anything (including legal proceedings) which is in the process of being done by or in relation to the Council before the transfer date.

(3) On or after the transfer date so far as is necessary or appropriate, references to the Council in any instruments, contracts or legal proceedings are to be treated as references to the National Assembly.

Accounts

8.-(1) The National Assembly must-

- (a) prepare a statement of accounts for the period from the date of the last statement of accounts prepared by the Council to the transfer date;
 - (b) send a copy of the statement to the Auditor General for Wales before the end of the period 6 months beginning with the transfer date.
- (2) The Auditor General for Wales must-
- (a) examine, certify and report on the statement received under this article;
 - (b) lay a copy of the report on the statement before the National Assembly.

Consequential amendments to Acts and other legislation

9.-(1) The Acts specified in Schedule 1 are amended in accordance with that Schedule.

(2) The subordinate legislation specified in Schedule 2 is amended in accordance with that Schedule.

Superannuation Act 1972 (c.11)

4. In section 23A (discrimination by Further Education and Higher Education Funding Councils):

- (a) omit "the National Council for Education and Training for Wales";
- (b) insert "and for the National Assembly for Wales in carrying out its functions under Part 2 of the Learning and Skills Act 2000" after "2000".

5. In section 25A (general duty: post-16 education and training etc.)-

- (a) in subsection (1) for "and the National Council for Education and Training for Wales" substitute "and the National Assembly for Wales";
- (b) in subsection (2) for "or the National Council for Education and Training for Wales" substitute "or the National Assembly for Wales by virtue of its functions under Part 2 of the Learning and Skills Act 2000".
- (c) for subsection (3) substitute-

"(3) The provisions of section 25 of the Learning and Skills Act 2000 shall be the only sanction for breach of the general duty in subsection (1) by the Learning and Skills Council for England."

(4) There shall be no sanction for breach of the general duty in subsection (1) by the National Assembly for Wales.

(5) Subsections (3) and (4) are without prejudice

to the enforcement of section 23A under section 66 or otherwise (where the breach is also a contravention of that section)."

10. Yn adran 5(9) o Ddeddf Personau Anabl (Gwasanaethau, Ymgynghori a Chynrychioli) 1986 (personau anabl yn gadael addysg arbennig) yn y diffiniad o "the responsible authority"-

9. In section 1(3)(g) of the Education (Fees and Awards) Act 1983 (fees at universities and further education establishments) for "National Council for Education and Training for Wales" substitute "National Assembly for Wales".

Disabled Persons (Services, Consultation and Representation) Act 1986 (c.33)

10. In section 5(9) of the Disabled Persons (Services, Consultation and Representation) Act 1986 (disabled persons leaving special education) in the definition of "the responsible authority"-

- (a) in paragraph (c), for "the National Council for Education and Training for Wales" substitute "the National Assembly for Wales";
- (b) at the end of paragraph (c) insert "or the National Assembly as the case may be".

Employment Act 1988 (c.19)

11. In section 26(1A) of the Employment Act 1988 (status of trainees etc), for "National Council for Education and Training for Wales" substitute "National Assembly for Wales".
