**EXPLANATORY NOTE**

Mae adran 28 o Ddeddf Llywodraeth Cymru 1998 yn rhoi i Gynulliad Cenedlaethol Cymru ("y Cynulliad Cenedlaethol") y pwerau mewn cysylltiad â strwythur cyrff cyhoeddus penodol yng Nghymru, sef y cyrff a restrir yn Atodlen 4 i'r Ddeddf honno.

Section 28 of the Government of Wales Act 1998 gives the National Assembly for Wales ("the National Assembly") powers with respect to the structure of certain public bodies in Wales listed in Schedule 4 to that Act.

Mae'n darparu y caiff y Cynulliad Cenedlaethol drosglwyddo swyddogaethau rhai o'r cyrff hynny i gorff arall o'r fath, i awdurdod lleol yng Nghymru neu iddo ef ei hun; ac y caiff ddiddymu cyrff o'r fath pan fydd eu swyddogaethau i gyd wedi'u trosglwyddo.

It provides that the National Assembly may transfer the functions of some of those bodies to another such body, to a Welsh local authority or to itself; and that it may abolish such bodies where all their functions have been transferred.

Mae'r Gorchymyn hwn yn trosglwyddo swyddogaethau Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru ("ACCAC") i'r Cynulliad Cenedlaethol, yn darparu ar gyfer trosglwyddo staff o ACCAC i'r Cynulliad Cenedlaethol ac yn gwneud darpariaethau canlyniadol, cysylltiedig, trosiannol ac atodol priodol.

This Order transfers the functions of the Qualifications, Curriculum and Assessment Authority for Wales ("ACCAC") to the National Assembly, provides for the transfer of staff from ACCAC to the National Assembly and makes appropriate consequential, incidental, transitional and supplementary provisions.

Mae erthygl 2 yn darparu ar gyfer trosglwyddo swyddogaethau ACCAC i'r Cynulliad Cenedlaethol.

Article 2 provides for the transfer of ACCAC's functions to the National Assembly.

Mae erthygl 3 yn darparu ar gyfer trosglwyddo staff ACCAC ac yn cymhwyso Rheoliadau Trosglwyddo Ymgymeriadau (Diogelu Cyflogaeth) 1981.

Article 3 provides for the transfer of ACCAC's staff and applies the Transfer of Undertakings (Protection of Employment) Regulations 1981.

Mae erthygl 4 yn darparu ar gyfer trosglwyddo eiddo, hawliau a rhwymedigaethau.

Article 4 provides for the transfer of property, rights and liabilities.

Mae erthygl 5 yn darparu ar gyfer parhad o ran arfer

Article 5 provides for continuity in the exercise of

swyddogaethau.

Mae erthygl 6 yn darparu bod ACCAC yn cael ei ddiddymu cyn gynted ag y trosglwyddir y swyddogaethau.

Mae erthyglau 7 ac 8 yn gwneud darpariaethau trosiannol penodol gan gynnwys mewn perthynas â pharatoi cyfrifon ar gyfer ACCAC gan y Cynulliad Cenedlaethol ar gyfer y flwyddyn ariannol 2005 - 2006.

Mae erthygl 9 yn darparu ar gyfer diwygiadau canlyniadol i ddeddfwriaeth sylfaenol ac is-ddeddfwriaeth.

Mae arfarniad rheoliadol wedi'i baratoi a gellir cael copïau gan Gynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd.

Article 6 provides that upon the transfer of the functions, ACCAC is abolished.

Articles 7 and 8 make certain transitional provisions including in relation to the preparation by the National Assembly of accounts for ACCAC for the financial year 2005- 2006.

Article 9 provides for consequential amendments to primary and subordinate legislation.

A regulatory appraisal has been prepared and copies are available from the National Assembly for Wales, Cathays Park, Cardiff.

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Awdurdod Cymwysterau, Cwricwlwm ac Asesu Cymru (Trosglwyddo Swyddogaethau i Gynulliad Cenedlaethol Cymru a Diddymu'r Awdurdod) 2005 a daw i rym ar 1 Ebrill 2006.

(2) Yn y Gorchymyn hwn:

ystyr "y Cynulliad Cenedlaethol" ("*the National Assembly*") yw Cynulliad Cenedlaethol Cymru;

The National Assembly for Wales, in accordance with the powers conferred upon it by section 28 of and Schedule 4 to the Government of Wales Act 1998(1), makes the following Order:

**Title, commencement and interpretation**

1.-(1) The title of this Order is the Qualifications, Curriculum and Assessment Authority for Wales (Transfer of Functions to the National Assembly for Wales and Abolition) Order 2005 and it comes into force on 1 April 2006.

(2) In this Order:

"the National Assembly" ("*y Cynulliad Cenedlaethol*") means the National Assembly for Wales;

"ACCAC" means the Qualifications, Curriculum and Assessment Authority for Wales;

"transfer date" ("*dyddiad trosglwyddo*") means 1 April 2006.

**Transfer of Functions of ACCAC to the National Assembly**

2. Subject to article 9, on the transfer date all the functions of ACCAC are transferred to the National Assembly.

### **Trosglwyddo staff**

3. At ddibenion Rheoliadau Trosglwyddo Ymgymeriadau (Diogelu Cyflogaeth) 1981(1)-

- (a) mae'r trosglwyddiad swyddogaethau a wneir gan Erthygl 2 i'w drin fel pe bai'n drosglwyddiad ymgymeriad;
- (b) mae pob person a oedd, yn union cyn y dyddiad trosglwyddo, yn gyflogedig gan ACCAC o dan gontract cyflogaeth i'w drin fel pe bai'n gyflogedig yn yr ymgymeriad yn union cyn y dyddiad trosglwyddo.

### **Trosglwyddo eiddo, hawliau a rhwymedigaethau**

4.-(1) Ar y dyddiad trosglwyddo, trosglwyddir yr holl eiddo, hawliau a rhwymedigaethau yr oedd gan ACCAC hawl iddynt neu yr oedd ACCAC yn ddarostyngedig iddynt yn union cyn y dyddiad trosglwyddo i'r Cynulliad Cenedlaethol.

(2) Bydd tystysgrif a ddyroddir gan y Cynulliad Cenedlaethol yn ardystio bod unrhyw eiddo, hawliau neu rwymedigaethau wedi'u trosglwyddo gan baragraff (1) yn dystiolaeth ddigamsyniol o'r trosglwyddiad.

(3) Nid yw'r cyfeiriad ym mharagraff (1) at hawliau a rhwymedigaethau yn cynnwys hawliau a rhwymedigaethau o dan gontract cyflogaeth a drosglwyddir yn rhinwedd erthygl 3.

(4) Mae i baragraff (1) effaith mewn cysylltiad ag eiddo, hawliau a rhwymedigaethau-

- (a) er gwaethaf unrhyw ddarpariaeth (o ba natur bynnag) a fyddai fel arall yn rhwystro eu trosglwyddo, neu'n ei gosbi, neu'n cyfyngu ar eu trosglwyddo a hynny ac eithrio drwy'r gorchymyn hwn;
- (b) heb fod unrhyw offeryn neu ffurfioldeb arall yn ofynnol.

### **Darpariaeth ar gyfer parhad o ran arfer swyddogaethau**

5. I'r graddau y mae'n ofynnol ar gyfer parhau ei effaith ar ac ar ôl y dyddiad trosglwyddo, rhaid i unrhyw beth a wnaed gan ACCAC, neu mewn perthynas ag ef, ac sy'n cael effaith yn union cyn y dyddiad trosglwyddo gael effaith fel pe bai wedi'i wneud gan y Cynulliad Cenedlaethol neu mewn perthynas â'r Cynulliad Cenedlaethol.

### **Diddymu ACCAC**

6. Ar y dyddiad trosglwyddo mae ACCAC yn peidio â bod.

### **Transfer of staff**

3. For the purposes of the Transfer of Undertaking (Protection of Employment) Regulations 1981(1)-

- (a) the transfer of functions effected by Article 2 is to be treated as a transfer of an undertaking;
- (b) each person who was, immediately before the transfer date, employed by ACCAC under a contract of employment is to be treated as employed in the undertaking immediately before the transfer date.

### **Transfer of property, rights and liabilities**

4.-(1) On the transfer date, all property, rights and liabilities to which ACCAC was entitled or subject immediately before the transfer date are transferred to the National Assembly.

(2) A certificate issued by the National Assembly that any property, rights or liabilities has been transferred by paragraph (1) shall be conclusive evidence of the transfer.

(3) The reference in paragraph (1) to rights and liabilities does not include rights and liabilities under a contract of employment transferred by virtue of article 3.

(4) Paragraph (1) has effect in relation to property, rights and liabilities-

- (a) despite any provision (of whatever nature) which would otherwise prevent, penalise or restrict their transfer otherwise than by this order;
- (b) without any instrument or other formality being required.

### **Provision for continuity in the exercise of functions**

5. Anything done by or in relation to ACCAC which has effect immediately before the transfer date shall so far as it is required for continuing its effect on and after the transfer date have effect as if done by or in relation to the National Assembly.

### **Abolition of ACCAC**

6. On the transfer date ACCAC ceases to exist.

## **Darpariaethau trosiannol etc**

7.-(1) Nid oes dim yn y Gorchymyn hwn yn effeithio ar ddilysrwydd unrhyw beth a wneir gan ACCAC neu mewn perthynas ag ef cyn y dyddiad trosglwyddo.

(2) Caniateir i'r Cynulliad Cenedlaethol barhau, neu caniateir parhau, mewn perthynas â'r Cynulliad Cenedlaethol, ag unrhyw beth (gan gynnwys achosion cyfreithiol) sydd yn y broses o gael ei wneud gan ACCAC neu mewn perthynas ag ACCAC cyn y dyddiad trosglwyddo.

(3) Ar neu ar ôl y dyddiad trosglwyddo, i'r graddau y bo hynny'n angenrheidiol neu'n briodol, rhaid trin cyfeiriadau at ACCAC, mewn unrhyw offerynnau, contractau, neu achosion cyfreithiol, fel pe baent yn gyfeiriadau at y Cynulliad Cenedlaethol.

(4) Hyd oni ddaw adran 189 o Ddeddf Addysg 2002 i rym, i'r graddau y bo'n ymwneud â pharagraff 5(5) o Atodlen 17 i'r Ddeddf honno, bydd adran 29 o Ddeddf Addysg 1997 (swyddogaethau ACCAC mewn perthynas â'r cwricwlwm ac asesu) yn cael effaith fel pe rhoddid yn lle is-adran (4)-

"(4) The National Assembly for Wales may exercise any function of a designated body within the meaning of Chapter 1 of Part 4".

## **Cyfrifon**

8.-(1) Rhaid i'r Cynulliad Cenedlaethol-

- (a) paratoi datganiad o gyfrifon ar gyfer y cyfnod sy'n cychwyn ar ddyddiad y datganiad diwethaf o gyfrifon a baratowyd gan ACCAC ac sy'n gorffen ar y dyddiad trosglwyddo;
- (b) anfon copi o'r datganiad at Archwilydd Cyffredinol Cymru cyn diwedd y cyfnod o 6 mis yn cychwyn ar y dyddiad trosglwyddo.

(2) Rhaid i Archwilydd Cyffredinol Cymru-

- (a) archwilio ac ardystio'r datganiad a ddaw i law o dan yr erthygl hon a llunio adroddiad arno;
- (b) gosod copi o'r adroddiad ar y datganiad gerbron y Cynulliad Cenedlaethol.

## **Diwygiadau canlyniadol i Ddeddfau a deddfwriaeth arall**

9.-(1) Diwygir y Deddfau a bennir yn Atodlen 1 yn unol â'r Atodlen honno.

(2) Diwygir yr is-ddeddfwriaeth a bennir yn Atodlen 2 yn unol â'r Atodlen honno.

## **Transitional provisions etc**

7.-(1) Nothing in this Order affects the validity of anything done by or in relation to ACCAC before the transfer date.

(2) There may be continued by or in relation to the National Assembly anything (including legal proceedings) which is in the process of being done by or in relation to ACCAC before the transfer date.

(3) On or after the transfer date so far as is necessary or appropriate, references to ACCAC in any instruments, contracts or legal proceedings are to be treated as references to the National Assembly.

(4) Until the coming into force of section 189 of the Education Act 2002 to the extent that it relates to paragraph 5(5) of Schedule 17 to that Act, section 29 of the Education Act 1997 (functions of ACCAC in relation to curriculum and assessment) shall have effect as if for subsection (4) there was substituted-

"(4) The National Assembly for Wales may exercise any function of a designated body within the meaning of Chapter 1 of Part 4".

## **Accounts**

8.-(1) The National Assembly must-

- (a) prepare a statement of accounts for the period from the date of the last statement of accounts prepared by ACCAC to the transfer date;
- (b) send a copy of the statement to the Auditor General for Wales before the end of the period of 6 months beginning with the transfer date;

(2) The Auditor General for Wales must-

- (a) examine, certify and report on the statement received under this article;
- (b) lay a copy of the report on the statement before the National Assembly.

## **Consequential amendments to Acts and other legislation**

9.-(1) The Acts specified in Schedule 1 are amended in accordance with that Schedule.

(2) The subordinate legislation specified in Schedule 2 is amended in accordance with that Schedule.

#### **House of Common Disqualification Act 1975 (c.24)**

2. In Part 3 of Schedule 1 to the House of Commons Disqualification Act 1975 (other disqualifying offices) omit "Any member of the Qualifications, Curriculum and Assessment Authority for Wales constituted under section 27 of the Education Act 1997 in receipt of remuneration."

#### **Deddf Cysylltiadau Hiliol 1976 (p.74)**

3. Yn Rhan 2 o Atodlen 1A i Ddeddf Cysylltiadau Hiliol 1976 (cyrff a phersonau eraill a ychwanegir ar ôl i'r ddyletswydd statudol gyffredinol ddechrau) hepgorer "The Qualifications, Curriculum and Assessment Authority for Wales."

#### **Race Relations Act 1976 (c.74)**

3. In Part 2 of Schedule 1A to the Race Relations Act 1976 (bodies and other persons added after commencement of general statutory duty) omit "The Qualifications, Curriculum and Assessment Authority for Wales."

#### **Deddf Elusennau 1993 (p.10)**

4. Yn Atodlen 2 i Ddeddf Elusennau 1993 (elusennau esempt) hepgorer paragraff (f).

#### **Charities Act 1993 (c.10)**

4. In Schedule 2 to the Charities Act 1993 (exempt charities) omit paragraph (f).

#### **Deddf Addysg 1996 (p.56)**

5. Yn adran 391(10)(b) o Ddeddf Addysg 1996 (swyddogaethau cynghorau ymgynghorol) yn lle "the Qualifications, Curriculum and Assessment Authority for Wales" rhodder "the National Assembly for Wales".

#### **Education Act 1996 (c.56)**

5. In section 391(10)(b) of the Education Act 1996, (functions of advisory councils) for "the Qualifications, Curriculum and Assessment Authority for Wales" substitute "the National Assembly for Wales".

#### **Deddf Addysg 1997 (p.44)**

6. Diwygir Deddf Addysg 1997 fel a ganlyn.

7. Yn adran 24 (swyddogaethau'r Awdurdod Cymwysterau, Cwricwlwm ac Asesu mewn perthynas â chymwysterau galwedigaethol ac academiaidd allanol) hepgorer is-adran (3).

#### **Education Act 1997 (c.44)**

6. The Education Act 1997 is amended as follows.

7. In section 24 (functions of the Qualifications and Curriculum Authority in relation to external vocational and academic qualifications) omit subsection (3).

8. For the heading to Chapter 2, substitute "Functions of the National Assembly for Wales".

9. Omit section 27 (the Qualifications, Curriculum and Assessment Authority for Wales), and the cross-heading immediately before it.

  - (i) yn lle "The Authority" rhodder "The National Assembly for Wales";
  - (ii) yn lle "their functions" rhodder "its functions";
  - (iii) yn lle "they have" rhodder "it has".

**13.** Yn adran 29 (swyddogaethau'r Awdurdod mewn perthynas â'r cwricwlwm ac asesu)-

- (a) yn is-adran (1) yn lle "The Qualifications, Curriculum and Assessment Authority for Wales" rhodder "The National Assembly for Wales";
- (b) yn is-adran (2)-
  - (i) hepgorer paragraff (b);
  - (ii) hepgorer paragraff (c).

**14.** Ym mhennawd adran 30, yn lle "Authority" rhodder "National Assembly for Wales".

**15.** Yn adran 30 (swyddogaethau'r Awdurdod mewn perthynas â chymwysterau galwedigaethol ac academaidd allanol)-

- (a) yn lle is-adran (1) rhodder-

"This section applies for the purposes of the following functions with respect to external qualifications in relation to Wales-

  - (i) to keep under review all aspects of such qualifications;
  - (ii) to provide support and advice to persons providing courses leading to such qualifications with a view to establishing and maintaining high standards in the provision of such courses;
  - (iii) to publish and disseminate, and assist in the publication and dissemination of, information relating to such qualifications;
  - (iv) to develop and publish criteria for the accreditation of such qualifications;

**10.** In the cross-heading immediately preceding section 28 and in the heading to section 28 for "Authority" substitute "National Assembly for Wales".

**11.** In section 28 (general functions of Authority to advance education and training)-

- (a) in subsection (1)-
  - (i) for "Qualifications, Curriculum and Assessment Authority for Wales" substitute "National Assembly for Wales";
  - (ii) for "the Authority" substitute "the National Assembly for Wales".
- (b) in subsection (2)-
  - (i) for "The Authority" substitute "The National Assembly for Wales";
  - (ii) for "their functions" substitute "its functions";
  - (iii) for "they have" substitute "it has".

**12.** In the heading to section 29, for "Authority" substitute "National Assembly for Wales."

**13.** In section 29 (functions of the Authority in relation to curriculum and assessment)-

- (a) in subsection (1) for "The Qualifications, Curriculum and Assessment Authority for Wales" substitute "The National Assembly for Wales."
- (b) in subsection (2)-
  - (i) omit paragraph (b);
  - (ii) omit paragraph (c).

**14.** In the heading to section 30, for "Authority" substitute "National Assembly for Wales".

**15.** In section 30 (functions of the Authority in relation to external vocational and academic qualifications)-

- (a) for subsection (1) substitute-

"This section applies for the purposes of the following functions with respect to external qualifications in relation to Wales-

  - (i) to keep under review all aspects of such qualifications;
  - (ii) to provide support and advice to persons providing courses leading to such qualifications with a view to establishing and maintaining high standards in the provision of such courses;
  - (iii) to publish and disseminate, and assist in the publication and dissemination of, information relating to such qualifications;
  - (iv) to develop and publish criteria for the accreditation of such qualifications;



- (v) to accredit, where they meet such criteria, any such qualifications submitted for accreditation;
- (vi) to make arrangements (whether or not with others) for the development, setting or administration of tests or tasks which fall to be undertaken with a view to obtaining such qualifications and which fall within a prescribed description."

(b) ar ôl is-adran (1) mewnosoder-

"(1A) In subsection (1)(d)-"criteria" includes criteria that are to be applied for the purpose of ensuring that the number of different accredited qualifications in similar subject areas or serving similar functions is not excessive; and paragraph (e) of that subsection is to be construed accordingly.";

(1B) Subject to subsection (2), with respect to external qualifications other than National Vocational Qualifications, the functions set out in subsection (1) are exercisable solely by the National Assembly for Wales.
