Title, commencement and application

1.-(1) The title of this Order is the Plant Breeders' Rights (Discontinuation of Prior Use Exemption) (Wales) Order 2006 and comes into force on 12 May 2006.

(2) This Order applies in relation to Wales.

2. Mae adran 9(5) o Ddeddf Amrywogaethau Planhigion 1997 yn peidio â chael effaith.

Discontinuation of Prior Use Exemption

2. Section 9(5) of the Plant Varieties Act 1997 ceases to have effect.

(2) Trosglwyddodd erthygl 2 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau 1999 ac Atodlen 1 iddo (O.S. 1999/672) swyddogaethau'r Gweinidogion o dan adran 9 o Ddeddf Amrywogaethau Planhigion 1997, i'r graddau y maent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru.

(2) Article 2 and Schedule 1 of the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) transferred the functions of the Ministers under Section 9 of the Plant Varieties Act 1997, so far as they are exercisable in relation to Wales, to the National Assembly for Wales.
