**NODYN ESBONIADOL****EXPLANATORY NOTE**

Mae'r Rheoliadau hyn yn gweithredu Cyfarwydddeb y Comisiwn 2006/55/EC ar 12 Mehefin 2006 sy'n diwygio Atodiad III i Gyfarwydddeb y Cyngor 66/402/EEC o ran mwyafswm pwysau lotiau hadau (O.J. Rhif L 159, 13.6.2006, t.13).

These Regulations implement Commission Directive 2006/55/EC of 12 June 2006 amending Annex III to Council Directive 66/402/EEC as regards the maximum weight of seed lots (O.J. No. L 159, 13.6.2006, p.13).

Maent yn diwygio Rheoliadau Hadau Ŷd (Cymru) 2005 (O.S. 2005/3036 (Cy. 224)) i gynyddu mwyafswm pwysau lot hadau o rywogaeth o hadau Ŷd, ac eithrio indrawn, o 25 tonnelli i 30 tonnelli. Maent hefyd yn gwneud diwygiad canlyniadol i Reoliadau Hadau Planhigion Porthiant (Cymru) 2005 (O.S. 2005/1207 (Cy. 79)) i sicrhau, lle mae mwy na 50% o lot hadau sy'n cynnwys cymysgedd o hadau planhigion porthiant a hadau y cynyddir y mwyafswm pwysau lot hadau ar eu cyfer gan y Rheoliadau hyn i 30 tonnelli, bod mwyafswm pwysau y lot hadau cymysg hefyd yn 30 tonnelli.

They amend the Cereal Seed (Wales) Regulations 2005 (S.I. 2005/3036 (W. 224)) to increase the maximum weight of a seed lot of species of cereal seed, except for maize, from 25 to 30 tonnes. They also make a consequential amendment to the Fodder Plant Seed (Wales) Regulations 2005 (S.I. 2005/1207 (W. 79)) to ensure that, where more than 50% of a seed lot comprising a mixture of fodder plant seed and seed for which the maximum weight of a seed lot is increased by these Regulations to 30 tonnes, the maximum weight of the mixed seed lot is also 30 tonnes.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adran 16(1), (1A), (3) a (4) o Ddeddf Amrywogaethau a Hadau Planhigion 1964(1) ac sydd bellach wedi'u breinio ynddo(2).

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred by section 16(1), (1A), (3) and (4) of the Plant Varieties and Seeds Act 1964(1) and now vested in it(2).

Yn unol ag adran 16(1) o'r Ddeddf honno mae wedi ymgynghori â chynrychiolwyr y buddiannau hynny y mae'n ymddangos iddo yr effeithir arnynt.

In accordance with section 16(1) of that Act it has consulted with representatives of such interests as appear to it to be concerned.

**Enwi, cychwyn a chymhwysu****Title, commencement and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Hadau Yd (Cymru) a Hadau Planhigion Porthiant (Cymru) (Diwygio) 2006.

1.-(1) The title of these Regulations is the Cereal Seed (Wales) and Fodder Plant Seed (Wales) (Amendment) Regulations 2006.

(2) Mae'r Rheoliadau hyn yn dod i rym ar 20 Rhagfyr 2006.

(2) These Regulations come into force on 20 December 2006.

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(3) These Regulations apply in relation to Wales.

**Diwygio Rheoliadau Hadau Yd (Cymru) 2005****Amendment of the Cereal Seed (Wales)  
Regulations 2005**

2.-(1) Diwygir Rheoliadau Hadau Yd (Cymru) 2005(3) fel a ganlyn.

2.-(1) The Cereal Seed (Wales) Regulations 2005(3) are amended as follows.

(1) 1964 c.14; section 16 was amended by section 4(1) of, and paragraph 5(1), (2) and (3) of Schedule 4 to, the European Communities Act 1972 (c. 68), S.I. 1977/1112 and section 2 of the Agriculture Act 1986 (c.49); see section 38(1) for a definition of "the Minister".

**Amendment of the Fodder Plant Seed (Wales) Regulations 2005**

3.-(1) The Fodder Plant Seed (Wales) Regulations 2005(1) are amended as follows.

(2) In regulation 23(3) (sampling), at the end, add-
