Maent yn darparu ar gyfer gweithredu a gorfodi Rheoliad y Comisiwn (EC) Rhif 1126/2007 sy'n diwygiod Rheoliad (EC) Rhif 1881/2006 sy'n gosod y lefelau uchaf ar gyfer halogion penodol mewn deunyddiau bwyd o ran tocsinau Fusarium mewn indrawn a chynhyrchion indrawn (OJ Rhif L255,29.9.2007, t.14).

2. Mae'r Rheoliadau'n diwygiod diffiniad o "Rheoliad y Comisiwn" yn Rheoliadau 2007 er mwyn cynnwys y diwygiadau y rhoddwyd effaith iddynt gan Reoliad y Comisiwn (EC) Rhif 1126/2007 (rheoliad 2).

3. Nid oes asesiad rheoleiddiol llawn wedi'i lunio ar gyfer yr offeryn hwn, gan na ragwelir y bydd yr offeryn yn effeithio o gwbl ar y sector preifat na'r sector gwirfoddol.

The Contaminants in Food (Wales)  
(Amendment) Regulations 2007

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

1. These Regulations, which apply in relation to Wales only, amend the Contaminants in Food (Wales) Regulations 2007 (S.I. 2007/840 W.73) ("the 2007 Regulations"). They make provision for the execution and enforcement of Commission Regulation (EC) No. 1126/2007 amending Regulation (EC) No. 1881/2006 setting maximum levels for certain contaminants in foodstuffs as regards Fusarium toxins in maize and maize products (OJ No. L255,29.9.2007, p.14).

2. The Regulations amend the definition of the "the Commission Regulation" in the 2007 Regulations so as to include the amendments effected by Commission Regulation (EC) No.1126/2007 (regulation 2).

3. A full regulatory assessment has not been produced for this instrument as no impact on the private or voluntary sectors is foreseen.

Fel sy'n ofynnol o dan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, ac yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn pennu gweithdrefnau o ran materion diogelwch bwyd(2), cafwyd ymgynghori agored a thryloyw â'r cyhoedd yn ystod cyfnod paratoi a gwerthuso'r Rheoliadau hyn.

(Amendment) Regulations 2007

Coming into force 19 December 2007

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(a), 17(2) and 48(1) of the Food Safety Act 1990(1).

In accordance with section 48(4A) of that Act, the Welsh Ministers have had regard to relevant advice given by the Food Standards Agency.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(2), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Trosglwyddwyd swyddogaethau i'r graddau y maent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S.1999/672) fel y'i darllenir ynghyd ag adran 40(3) o Ddeddf 1999. Mae swyddogaethau Cynulliad Cenedlaethol Cymru bellach yn arferadwy gan Weimidoigion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (2006 c.32).

Functions so far as exercisable in relation to Wales, were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) as read with section 40(3) of the 1999 Act. Functions of the National Assembly for Wales are now exercisable by the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (2006 c.32).

## **Title, application and commencement**

**1.** The title of these Regulations is the Contaminants in Food (Wales) (Amendment) Regulations 2007, apply in relation to Wales and they come into force on 19 December 2007.

## **Amendment of the Contaminants in Food (Wales) Regulations 2007**

**2.**-(1) The Contaminants in Food (Wales) Regulations 2007**(1)** are amended in accordance with paragraph (2).

(2) In regulation 2 (interpretation), for the definition of "the Commission Regulation" substitute the following—

""the Commission Regulation" ("*Rheoliad y Comisiwn*") means Commission Regulation (EC) No. 1881/2006 setting maximum levels for certain contaminants in foodstuffs**(2)** as amended by Commission Regulation (EC) No. 1126/2007 amending Regulation (EC) No 1881/2006 setting maximum levels for certain contaminants in foodstuffs as regards Fusarium-toxins in maize and maize products**(3)**".
