Mae'r Gorchymyn hwn yn dwyn i rym ddarpariaethau pellach Deddf Cymdogaethau Glân a'r Amgylchedd 2005 ("Deddf 2005") o ran Cymru.

Mae erthygl 2 o'r Gorchymyn hwn yn dwyn i rym ar 18 Ionawr 2008 ddarpariaethau canlynol Deddf 2005:

- (a) paragraffau 5 i 7 o Atodlen 4 i Ddeddf 2005 sy'n gwneud mân ddiwygiadau i destun Deddf Diogelu'r Amgylchedd 1990 ("Ddeddf 1990");
- (b) paragraff 8 o Atodlen 4 i Ddeddf 2005 sy'n diwygio adran 95(1)(c) o Ddeddf 1990 fel bod y gofrestr gyhoeddus o orchmynion a hysbysiadau, y mae adran 95 o Ddeddf 1990 yn ei gwneud yn ofynnol i awdurdodau lleol ei chadw, yn cynnwys copïau o bob gorchymyn a wneir o dan baragraff 2(1) o Atodlen 3A i Ddeddf 1990 mewn perthynas â dynodi tir at ddibenion rheoleiddio dosbarthu deunydd printiedig yn ddi-dâl;
- (c) paragraff 9 o Atodlen 4 i Ddeddf 2005 sy'n diwygio adran 96 o Ddeddf 1990 gyda'r effaith o alluogi Gweinidogion Cymru i wneud rheoliadau mewn perthynas ag ysbwriel a gaiff ei gasglu gan brif awdurdodau ysbwriel o dan adran 92C(3) o Ddeddf 1990. Mae adran 92C(3) o Ddeddf 1990 yn ymwneud ag ysbwriel a gesglir gan brif awdurdod ysbwriel pan fydd person wedi methu â chydymffurfio â hysbysiad clirio ysbwriel a ddyroddwyd gan yr awdurdod hwnnw o dan adran 92A o Ddeddf 1990;

The Clean Neighbourhoods and
Environment Act 2005
(Commencement No. 3) (Wales)
Order 2007

EXPLANATORY NOTE

(This note is not part of the Order)

This Order brings into force further provisions of the Clean Neighbourhoods and Environment Act 2005 ("the 2005 Act") in relation to Wales.

Article 2 of this Order brings into force on 18 January 2008 the following provisions of the 2005 Act:

- (a) paragraphs 5 to 7 of Schedule 4 to the 2005 Act which make minor textual amendments to the Environmental Protection Act 1990 ("the 1990 Act");
- (b) paragraph 8 of Schedule 4 to the 2005 Act which amends section 95(1)(c) of the 1990 Act so that the public register of orders and notices, which local authorities are required by section 95 of the 1990 Act to maintain, includes copies of all orders which are made under paragraph 2(1) of Schedule 3A to the 1990 Act in relation to the designation of land for the purposes of regulating the free distribution of printed matter;
- (c) paragraph 9 of Schedule 4 to the 2005 Act which amends section 96 of the 1990 Act with the effect of enabling Welsh Ministers to make regulations in relation to litter collected by principal litter authorities under section 92C(3) of the 1990 Act. Section 92C(3) of the 1990 Act relates to litter collected by a principal litter authority when a person has failed to comply with a litter clearing notice issued by that authority under section 92A of the 1990 Act;

- (ch) mae paragraff 14 o Atodlen 4 i Ddeddf 2005 yn rhoi is-adran (1) newydd yn adran 45 o Ddeddf Ymddygiad Gwrthgymdeithasol 2003 ("Deddf 2003") gyda'r effaith bod cosbau penodedig yn unol ag adran 43(1) (graffiti a gosod posterï'n anghyfreithlon) o Ddeddf 2003 yn daladwy i'r awdurdod lleol y dyroddwyd yr hysbysiad gan ei swyddog awdurdodedig;
- (d) mae paragraff 14 of Schedule 4 to the 2005 Act substitutes a new subsection (1) into section 45 of the Anti-social Behaviour Act 2003 ("the 2003 Act") with the effect that fixed penalties pursuant to section 43(1) (graffiti and fly-posting) of the 2003 Act are payable to the local authority whose authorised officer issued the notice;
- (d) mae paragraff 15 o Atodlen 4 i Ddeddf 2005 yn cymhwyso i adrannau 43A a 43B o'r Ddeddf honno ddiffiniadau a geir yn adran 47(1) o Ddeddf 2003. Effaith hyn yw galluogi Gweinidogion Cymru i wneud rheoliadau mewn cysylltiad â chosbau sy'n daladwy yn unol â hysbysiad o dan adran 43(1) o Ddeddf 2003 (graffiti a gosod posterï'n anghyfreithlon);
- (e) paragraph 15 of Schedule 4 to the 2005 Act applies definitions contained in section 47(1) of the 2003 Act to sections 43A and 43B of that Act. The effect of this is to enable Welsh Ministers to make regulations in connection with penalties payable in pursuance of a notice under section 43(1) of the 2003 Act (graffiti and fly-posting);
- (dd) mae paragraffau 16 i 19 o Atodlen 4 i Ddeddf 2005 yn rhoi'r term "defacement removal notice" yn lle "graffiti removal notice" yn adrannau 48, 49 a 51 o Ddeddf 2003, ac ym mhennawd adran 52 o'r Ddeddf honno;
- (f) paragraphs 16 to 19 of Schedule 4 to the 2005 Act substitute the term "defacement removal notice" for "graffiti removal notice" in sections 48, 49 and 51 of the 2003 Act, and in the heading of section 52 in that Act.
- (e) mae paragraff 17(7) o Atodlen 4 i Ddeddf 2005 yn mewnosod y geiriau "but not a parish or community council" yn y diffiniad o "local authority" yn adran 48(12) o Ddeddf 2003. Effaith hyn yw atal cynghorau plwyf a chynghorau cymuned rhag dyroddi hysbysïadau gwaredu graffiti, rhag cyflawni gwaith adfer pan na chydymffurfir â hysbysiad gwaredu graffiti a rhag adennill treuliau a dynnir wrth wneud hynny;
- (g) paragraph 17(7) of Schedule 4 to the 2005 Act inserts the words "but not a parish or community council" into the definition of "local authority" in section 48(12) of the 2003 Act. The effect of this is to prevent parish and community councils from issuing graffiti removal notices, carrying out remedial works where a graffiti removal notice is not complied with and recovering expenses incurred in doing so;
- (f) mae Rhan 3 o Atodlen 5 i Ddeddf 2005 yn cynnwys diddymiadau i adran 324(3)(a) o Ddeddf Cynllunio Gwlad a Thref 1990 ac adran 43(10) ac (11) o Ddeddf Ymddygiad Gwrthgymdeithasol 2003;
- (h) Part 3 of Schedule 5 to the 2005 Act contains repeals to section 324(3)(a) of the Town and Country Planning Act 1990 and section 43(10) and (11) of the Anti-social Behaviour Act 2003;
- (ff) mae Rhan 7 o Atodlen 5 i Ddeddf 2005 yn cynnwys diddymiadau i adran 9 o Ddeddf Swm a Niwsans Statudol 1990 ac Atodlen 3 iddi ac i'r pennawd i adran 2 ac adrannau 8(8) a 9(3) o Ddeddf Swm 1996;
- (i) Part 7 of Schedule 5 to the 2005 Act contains repeals to section 9 and Schedule 3 to the Noise and Statutory Nuisance Act 1990 and to the heading to section 2 and sections 8(8) and 9(3) of the Noise Act 1996;
- (g) mae Rhan 9 o Atodlen 5 i Ddeddf 2005 yn cynnwys diddymiad i adran 45(3) i (9) o Ddeddf Ymddygiad Gwrthgymdeithasol 2003.
- (j) Part 9 of Schedule 5 to the 2005 Act contains a repeal to section 45(3) to (9) of the Anti-social Behaviour Act 2003.
