**EXPLANATORY NOTE**

Caiff y Rheoliadau hyn eu gwneud o dan adrannau 30 a 65 o Ddeddf Galluedd Meddyliol 2005 ("y Ddeddf")(p.9) ac maent yn diffinio 'corff priodol' at ddibenion adrannau 30 i 32 o'r Ddeddf honno. Mae adran 30(1) o'r Ddeddf honno'n darparu bod ymchwil penodol a gaiff ei wneud i berson neu mewn perthynas â pherson sydd heb alluedd yn anghyfreithlon oni chaiff ei wneud yn rhan o brosiect a gymeradwywyd gan gorff priodol a'i fod yn bodloni gofynion pellach a bennir yn y Ddeddf.

These Regulations are made under sections 30 and 65 of the Mental Capacity Act 2005 ("the Act") (c.9) and define 'appropriate body' for the purposes of sections 30 to 32 of that Act. Section 30(1) of that Act provides that certain research carried out on or in relation to a person without capacity is unlawful unless it is carried out as part of a project which is approved by an appropriate body and satisfies further requirements specified in the Act.

Mae rheoliad 1 yn darparu byd y Rheoliadau hyn yn gymwys o ran gwneud ymchwil yng Nghymru. Mae'n ychwanegol yn darparu i'r Rheoliadau ddod i rym ar 1 Gorffennaf 2007 at ddibenion galluogi ceisiadau am gymeradwyaeth i ymchwil gael ei wneud a phenderfynu arno o dan y Ddeddf ac i ddod i rym ar 1 Hydref 2007 at bob diben arall.

Regulation 1 provides that these Regulations apply in relation to research carried out in Wales. It further provides for the Regulations to come into force on 1 July 2007 for the purposes of enabling applications for approval of research to be made and determined under the Act and on 1 October 2007 for all other purposes.

Mae rheoliad 2 yn diffinio corff priodol fel pwyllgor a sefydlwyd i gynghori ar foeseq ymchwil ymwithiol, neu ar faterion sy'n cynnwys moeseg ymchwil ymwithiol, mewn perthynas â phobl nad yw'r galluedd ganddynt i gydsynio iddo ac a gydnabyddir i'r diben hwnnw gan Gynulliad Cenedlaethol Cymru.

Regulation 2 defines an appropriate body as a committee which is established to advise on, or on matters which include, the ethics of intrusive research in relation to people who lack capacity to consent to it and which is recognised for that purpose by the National Assembly for Wales.

Mae Arfarniad Rheoliadol wedi'i baratoi ar gyfer Deddf Galluedd Meddyliol 2005 a gosodwyd copi ohono yn llyfrgell Cynulliad Cenedlaethol Cymru.

A Regulatory Appraisal was prepared for the Mental Capacity Act 2005 and a copy has been placed in the library of the National Assembly for Wales.

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Deddf Galluedd Meddyliol 2005 (Corff Priodol) (Cymru) 2007 a deuant i rym-

1.-(1) The title of these Regulations is the Mental Capacity Act 2005 (Appropriate Body) (Wales) Regulations 2007 and they come into force on -

- (a) ar 1 Gorffennaf 2007 at ddibenion galluogi ceisiadau ar gyfer cymeradwyaeth o ran ymchwil i gael eu gwneud i gorff priodol ac i gael eu penderfynu ganddo,
- (b) ar 1 Hydref 2007 at bob diben arall.

- (a) 1 July 2007 for the purpose of enabling applications for approval in relation to research to be made to, and determined by, an appropriate body,
- (b) 1 October 2007 for all other purposes.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

(2) These Regulations apply in relation to Wales.

2. At ddibenion adrannau 30, 31 a 32 o Ddeddf Galluedd Meddyliol 2005, y corff priodol o ran prosiect ymchwil yw pwyllgor-

2. For the purposes of sections 30, 31 and 32 of the Mental Capacity Act 2005, the appropriate body in relation to a research project is a committee-

- (a) a sefydlwyd i gynghori ar foeseq ymchwil ymwithiol neu ar faterion sy'n cynnwys moeseg ymchwil ymwithiol mewn perthynas â phobl nad yw'r galluedd ganddynt i gydsynio iddo; a

- (a) established to advise on, or on matters which include the ethics of intrusive research in relation to people who lack capacity to consent to it; and

(b) a gydnabyddir at y dibenion hynny gan  
Gynulliad Cenedlaethol Cymru.

(b) recognised for those purposes by the National  
Assembly for Wales.
