Mae'r Rheoliadau hyn, sy'n gymwys o ran Cymru, yn diwygio Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) 1992 ("Rheoliadau 1992"). Mae'r Rheoliadau hyn yn dirymu Rheoliadau Cyfraniadau Ardrethu Annomestig (Cymru) (Diwygio) 2008.

These Regulations, which apply in relation to Wales, amend the Non-Domestic Rating Contributions (Wales) Regulations 1992 ("the 1992 Regulations"). These Regulations revoke the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2008.

O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol 1988 mae'n ofynnol i awdurdodau bilio (yng Nghymru, cyngorau sir a chynghorau bwrdeistref sirol) dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Weinidogion Cymru. Mae Rheoliadau 1992 yn cynnwys rheolau ar gyfer cyfrifo'r cyfraniadau hynny ar gyfer awdurdodau bilio Cymru.

Under Part II of Schedule 8 to the Local Government Finance Act 1988 billing authorities (in Wales, county and county borough councils) are required to pay amounts (called non-domestic rating contributions) to the Welsh Ministers. The 1992 Regulations contain rules for the calculation of those contributions for Welsh billing authorities.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 1992 drwy roi Atodlen 4 newydd yn lle'r un bresennol (Ffigurau Poblogaeth Oedolion).

These Regulations amend the 1992 Regulations by substituting a new Schedule 4 (Adult Population Figures).

The Welsh Ministers make the following Regulations in exercise of the powers conferred on the Secretary of State by sections 60, 140(4) and 143(1) of, and paragraphs 4 and 6 of Schedule 8 to, the Local Government Finance Act 1988(1).

Title, commencement and application

1.—(1) The title of these Regulations is The Non-Domestic Rating Contributions (Wales) (Amendment) (No.2) Regulations 2008 and they come into force on 31 December 2008.

(2) These Regulations apply in relation to Wales.

Revocation

2. The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2008(2) are revoked.
