Made *28 March 2008*
Coming into force *1 April 2008*

The Welsh Ministers in exercise of powers conferred by section 204(1) and paragraph 28(1) of Schedule 3 to the National Health Service (Wales) Act 2006⁽¹⁾ and after completion of consultation prescribed under paragraph 28(3) of Schedule 3 to that Act⁽²⁾ hereby make the following Order:

Title and Commencement

1. The Title of this Order is the Ceredigion and Mid Wales National Health Service Trust (Dissolution) Order 2008 and it comes into force on 1 April 2008.

Dissolution of NHS Trust

2. The Ceredigion and Mid Wales National Health Service Trust established by the Ceredigion and Mid Wales National Health Service Trust (Establishment) Order 1992(3) is hereby dissolved, and accordingly that Order is hereby revoked.
