Mae'r Gorchymyn hwn yn gwneud darpariaeth am yr uchafsymiau y gellir eu hadennill am wasanaethau a threuliau swyddogion cyfrif mewn cysylltiad â'r refferendwm sydd i'w gynnal yn unol â Gorchymyn Refferendwm Cynulliad Cenedlaethol Cymru (Darpariaethau Deddfau'r Cynulliad) (Cwestiwn y Refferendwm, Dyddiad y Refferendwm Etc.) 2010 ("Gorchymyn y Refferendwm").

This Order makes provision about the maximum recoverable amounts for the services and expenses of counting officers in connection with the referendum that is to be held in accordance with the National Assembly for Wales Referendum (Assembly Act Provisions) (Referendum Question, Date of Referendum Etc.) Order 2010 ("the Referendum Order").

Mae'r Gorchymyn hwn wedi ei wneud o dan erthygl 13 o Orchymyn y Refferendwm sy'n gosod darpariaeth bellach am adennill symiau am y gwasanaethau a'r treuliau hyn gan swyddogion cyfrif.

This Order is made under article 13 of the Referendum Order which sets out further provision in respect of the recovery by counting officers of amounts for such services and expenses.

Mae erthygl 2 o'r Gorchymyn hwn yn pennu'r uchafswm cyffredinol y gellir ei adennill ar gyfer pob ardal bleidleisio yng ngholofn 4 o'r Tabl yn yr Atodlen.

Article 2 of this order specifies the overall maximum recoverable amount for each voting area in column 4 of the Table in the Schedule.

Mae erthygl 3 o'r Gorchymyn hwn yn pennu na chaiff y cyfanswm y gall pob swyddog cyfrif ei adennill o ran y gwasanaethau penodedig a ddisgrifir yn erthygl 4 o'r Gorchymyn hwn fod yn fwy na'r swm a restrir ar gyfer pob ardal bleidleisio yng ngholofn 2 o'r Tabl yn yr Atodlen.

Article 3 of this Order specifies that the total of the amount recoverable by each counting officer in respect of the specified services described in article 4 of this Order must not be more than the amount that is listed for each voting area in column 2 of the Table in the Schedule.

Mae erthygl 5 o'r Gorchymyn hwn yn pennu na chaiff y cyfanswm y gall pob swyddog cyfrif ei adennill o ran y treuliau penodedig a ddisgrifir yn erthygl 6 o'r Gorchymyn hwn fod yn fwy na'r swm a restrir ym mhob ardal bleidleisio yng ngholofn 3 o'r Tabl yn yr Atodlen.

Article 5 of this Order specifies that the total of the amount recoverable by each counting officer in respect of the specified expenses described in article 6 of this Order must not be more than the amount that is listed for each voting area in column 3 of the Table in the Schedule.

The Welsh Ministers, in exercise of the powers conferred by article 13(1)(b), (2) and (6) of the National Assembly for Wales Referendum (Assembly Act Provisions) (Referendum Question, Date of Referendum Etc.) Order 2010(1), make the following Order:

**Title, application and commencement**

1.–(1)Enw'r Gorchymyn hwn yw Gorchymyn Refferendwm Cynulliad Cenedlaethol Cymru (Darpariaethau Deddfau'r Cynulliad) (Taliadau Swyddogion Cyfrif) 2010 .

1.–(1) The title of this Order is the National Assembly for Wales Referendum (Assembly Act Provisions) (Counting Officers' Charges) Order 2010.

(2) Daw'r Gorchymyn hwn i rym drannoeth y diwrnod y'i gwneir.

(2) This Order comes into force on the day after the day on which it is made.

(3) Mae'r Gorchymyn hwn yn gymwys o ran Cymru.

(3) This Order applies in relation to Wales.

## Yr uchafswm adenilladwy cyffredinol

2. Yr uchafswm adenilladwy cyffredinol ar gyfer ardal bleidleisio(1) yw'r swm a restrir yng ngholofn 4 o'r Tabl yn yr Atodlen.

## Yr uchafswm adenilladwy ar gyfer gwasanaethau penodedig

3. Rhaid i gyfanswm y taliadau sy'n adenilladwy gan swyddog cyfrif(2) o ran y gwasanaethau o'r disgrifiad penodedig yn erthygl 4 beidio â bod yn fwy na'r swm a restrir ar gyfer pob ardal bleidleisio yng ngholofn 2 o'r Tabl yn yr Atodlen.

4. Dyma'r gwasanaethau penodedig—

- (a) gwneud trefniadau ar gyfer y refferendwm(3);
- (b) cyflawni swyddogaethau'r swyddog cyfrif o ran y refferendwm; a
- (c) cynnal y refferendwm .

## Yr uchafswm adenilladwy ar gyfer treuliau penodedig

5. Rhaid i gyfanswm y taliadau sy'n adenilladwy gan swyddog cyfrif o ran y treuliau o'r disgrifiad penodedig yn erthygl 6 beidio â bod yn fwy na'r swm a restrir ar gyfer pob ardal bleidleisio yng ngholofn 3 o'r Tabl yn yr Atodlen.

6. Dyma'r treuliau penodedig—

- (a) penodi a thalu personau i gynorthwyo'r swyddog cyfrif (gan gynnwys personau y cyfeirir atynt yn adran 128(4) o Ddeddf Pleidiau Gwleidyddol, Etholiadau a Refferenda 2000)(4);
- (b) teithio a chynhaliadau ar gyfer y swyddog cyfrif ac unrhyw berson y cyfeirir ato ym mharagraff (a);
- (c) argraffu neu gynhyrchu papurau pleidleisio;

## Overall maximum recoverable amount

2. The overall maximum recoverable amount for each voting area(1) is the amount listed in column 4 of the Table in the Schedule.

## Maximum recoverable amount for specified services

3. The total of the charges recoverable by a counting officer(2) in respect of the services of the description specified in article 4 must not exceed the amount listed for each voting area in column 2 of the Table in the Schedule.

4. The specified services are—

- (a) making arrangements for the referendum(3);
- (b) discharging the counting officer's duties in respect of the referendum; and
- (c) conducting the referendum .

## Maximum recoverable amount for specified expenses

5. The total of the charges recoverable by a counting officer in respect of the expenses of the description specified in article 6 must not exceed the amount listed for each voting area in column 3 of the Table in the Schedule.

6. The specified expenses are—

- (a) the appointment and payment of persons to assist the counting officer (including persons referred to in section 128(4) of the Political Parties, Elections and Referendums Act 2000)(4);
- (b) travel and subsistence for the counting officer and any person referred to in paragraph (a);
- (c) printing or production of ballot papers;

- (g) renting, heating, lighting, cleaning, adapting or restoring (including making good any damage done to) any building or room;
- (h) providing and transporting equipment necessary for the conduct of the referendum;
- (i) providing information and communications technology equipment and software and associated costs;
- (j) providing security and storage of ballot boxes, ballot papers and other documents for or in connection with the referendum;
- (k) conducting the verification and the count (including any re-count) ;
- (l) providing and receiving training;
- (m) stationery, postage and delivery, telephone, printing, translation, banking and miscellaneous costs; and
- (n) the supply of copies of (or of parts of) the register for use in the conduct of the referendum.
