- (b) am roi hwb ymlaen i gyfartal rhwng personau sy'n rhannu nodwedd warchodedig berthnasol a phersonau nad ydynt yn ei rhannu;
- (c) am feithrin perthynas dda rhwng personau sy'n rhannu nodwedd warchodedig berthnasol a phersonau nad ydynt yn ei rhannu.

Mae'r awdurdodau a restrir yn Rhan 2 o Atodlen 19, fel y'i diwygir gan y Gorchymyn hwn, hefyd yn ddarostyngedig i ddyletswyddau cydraddoldeb penodol a osodir gan Weinidogion Cymru yn rhinwedd Rheoliadau Deddf Cydraddoldeb 2010 (Dyletswyddau Statudol) (Cymru) 2011 o dan y pŵer a roddwyd iddynt gan adran 153(2) o'r Ddeddf.

Mae'r Gorchymyn hwn yn hepgor cofnodion o'r rhestr o awdurdodau a bennir. Fodd bynnag, bydd yr awdurdodau a hepgorwyd ac sy'n arfer swyddogaethau cyhoeddus yn parhau'n ddarostyngedig i'r ddyletswydd gyffredinol yn adran 149(1) o'r Ddeddf wrth arfer y swyddogaethau hynny, yn rhinwedd adran 149(2) o'r

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the list of authorities specified in Part 2 of Schedule 19 to the Equality Act 2010 ("the Act"). These authorities are subject to the public sector equality duty ("general duty") set out in section 149 of the Act, by virtue of section 150 of the Act, to have due regard, when exercising their functions, to the need to—

- (a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- (c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

The authorities listed in Part 2 of Schedule 19, as amended by this Order, are also subject to specific equality duties imposed by the Welsh Ministers by virtue of the Equality Act 2010 (Statutory Duties) (Wales) Regulations 2011 under the power conferred on them by section 153(2) of the Act.

This Order omits entries from the list of authorities specified. However, the authorities omitted that exercise public functions will remain subject to the general duty in section 149(1) of the Act in the exercise of those functions, by virtue of section 149(2) of the Act. Articles 2(a), (b) and (d) amend Part 2 of

Coming into force in accordance with article 1

In accordance with section 209(2), (3) and (6) of the Equality Act 2010(1), a draft of this instrument has been laid before and approved by a resolution of the National Assembly for Wales.

In accordance with section 152(2) of that Act the Welsh Ministers have obtained the consent of a Minister of the Crown and have consulted the Commission for Equality and Human Rights.

The Welsh Ministers, in exercise of the powers conferred by section 151(2) of the Equality Act 2010, make the following Order:

Title, commencement and application

1.—(1) The title of this Order is the Equality Act 2010 (Specification of Relevant Welsh Authorities) Order 2011.

(2) This Order comes into force on the day after the day on which it is made.
