Mae'r Gorchymyn hwn yn pennu mai 1 Ebrill 2011 fydd y diwrnod y caiff adrannau 49 a 50 o Ddeddf 2009 eu dwyn i rym yn rhannol.

Mae adran 49 o Ddeddf 2009 yn gwrth-droi effaith adran 562 o Ddeddf Addysg 1996 ("Deddf 1996") i blant a phobl ifanc sydd dan gadwad mewn llety ieuentid perthnasol (fel y bydd swyddogaethau awdurdodau lleol, Gweinidogion Cymru, a rhieni o dan Ddeddf 1996 yn gymwys yn gyffredinol tuag at bersonau o'r fath). Deuir ag adran 49 i rym at ddibenion y diwygiadau i Ddeddf 1996 sydd wedi eu cynnwys yn adran 50 o Ddeddf 2009 ac sy'n cael eu dwyn i rym gan y Gorchymyn hwn.

Mae adran 50 o Ddeddf 2009 yn mewnosod nifer o adrannau yn Neddf 1996. Deuir â rhai o'r darpariaethau hyn i rym fel a ganlyn. Mae adran 562A(3) yn diffinio person sydd dan gadwad at ddibenion Deddf 1996. Order 2011**

EXPLANATORY NOTE

(This note is not part of the Order)

This Order is the third Commencement Order made by the Welsh Ministers under the Apprenticeships, Skills, Children and Learning Act 2009 ("the 2009 Act"), which brings specified provisions of the 2009 Act into force so far as relating to Wales.

Sections 48 to 52 of the 2009 Act make provision in relation to education and training for children and young people subject to detention in relevant youth accommodation.

This Order appoints 1 April 2011 as the day on which sections 49 and 50 of the 2009 Act are brought into force in part.

Section 49 of the 2009 Act reverses the effect of section 562 of the Education Act 1996 ("the 1996 Act") for children and young people detained in relevant youth accommodation (so that functions of local authorities, the Welsh Ministers, and parents under the 1996 Act will generally apply towards such persons). Section 49 is brought into force for the purposes of the amendments to the 1996 Act contained in section 50 of the 2009 Act which are brought into force by this Order.

Section 50 of the 2009 Act inserts a number of sections into the 1996 Act. Certain of these provisions are brought into force as follows. Section 562A(3) defines a detained person for the purposes of the 1996 Act. Section 562B(1) to (3) requires a home authority (i.e. usually the local authority where a person ordinarily lives) to take steps to promote the fulfilment

Mae adran 51 o Ddeddf 2009 yn diwygio Deddf Troseddau ac Anhrefn 1998 er mwyn gosod dyletswydd ar dîmau troseddau ieuencid i roi gwybod i awdurdodau lleol penodol pan fydd person yn cael ei roi dan gadwad mewn llety ieuencid perthnasol, ei drosglwyddo iddo neu ei ryddhau ohono.

Mae'r Gorchymyn hefyd yn pennu mai 1 Ebrill 2011 fydd y diwrnod y caiff adran 52 o Ddeddf 2009 eu dwyn i rym. Mae adran 52 yn mewnosod adran 312A newydd yn Neddf 1996 sy'n gwneud darpariaeth ynghylch datganiadau o anghenion addysgol arbennig pan ryddheir rhywun sy'n cael ei gadw ac sydd hefyd yn diwygio adran 328(5) o Ddeddf 1996 i'w gwneud yn ofynnol i awdurdod lleol adolygu datganiad pan gaiff plentyn ei ryddhau o fod dan gadwad.

of a detained person's learning potential. Section 562C(1) and (2) make provision in relation to statements of special educational needs during the time a child is detained. Section 562F(1) to (6) and (11) make provision about the sharing of education-related information relating to a detained person. Section 562I requires a local authority to have regard to Welsh Ministers' guidance in performing their functions in relation to detained persons in youth accommodation and section 562J contains definitions.

This Order also appoints 1 April 2011 as the day on which section 51 of the 2009 Act is brought into force. Section 51 of the 2009 Act amends the Crime and Disorder Act 1998 so as to impose a duty on youth offending teams to notify certain local authorities when a person is detained in, transferred to, or released from, relevant youth accommodation.

This Order also appoints 1 April 2011 as the day on which section 52 of the 2009 Act is brought into force. Section 52 inserts a new section 312A into the 1996 Act which makes provision about statements of special educational needs on release from detention and also amends section 328(5) of the 1996 Act to require a local authority to review a statement on a child's release from detention.

The Welsh Ministers make the following Order in exercise of the powers conferred by section 269(3) and (8) of the Apprenticeships, Skills, Children and Learning Act 2009(1):

Title and interpretation

1.–(1) The title of this Order is the Apprenticeships, Skills, Children and Learning Act 2009 (Commencement No. 3) (Wales) Order 2011.

(2) In this Order "the Act" ("*y Ddeddf*") means the Apprenticeships, Skills, Children and Learning Act 2009.

Appointed day

2. 1 April 2011 is the appointed day for the coming into force of the following provisions so far as relating to Wales—

- (a) section 49 (persons detained in youth accommodation: application of provisions) for the purposes of—
 - (i) section 50 of the Act to the extent it is brought into force by sub-paragraph (b); and
 - (ii) section 52 of the Act;
- (b) section 50 (persons detained in youth accommodation: further provision) to the extent that it inserts the following provisions into the Education Act 1996—
 - section 562A(3);
 - section 562B(1) to (3);
 - section 562C(1) and (2);
 - section 562F(1) to (6) and (11);

- adran 562I; ac
adran 562J;
- (c) adran 51 (cadw plentyn neu person ifanc: rhoi gwybod i awdurdodau lleol);
 - (ch) adran 52 (rhyddhad plentyn neu person ifanc sy'n cael ei gadw sydd ag anghenion addysgol arbennig); a
 - (d) paragraffau 54 i 56 o Atodlen 6.

section 562J;
- (c) section 51 (detention of child or young person: local education authorities to be notified);
 - (d) section 52 (release from detention of child or young person with special educational needs); and
 - (e) paragraphs 54 to 56 of Schedule 6.
