ROAD TRAFFIC, WALES

The A487 Trunk Road (Powys-Ceredigion Border to Dyfi Bridge, North of Machynlleth, Powys) (Temporary Traffic Restrictions and No Overtaking) Order 2014

Made 1 December 2014

Coming into force 8 December 2014

The Welsh Ministers, being the traffic authority for the relevant length of the Fishguard – Bangor Trunk Road (A487) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited because of works proposed on or near the road.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 8 December 2014. The title to this Order is The A487 Trunk Road (Powys – Ceredigion Border to Dyfi Bridge, North of Machynlleth, Powys) (Temporary Traffic Restrictions and No Overtaking) Order 2014.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the A487 trunk road in the County of Powys which extends from the Powys/Ceredigion County boundary at Pont Llyfnant, in a north-easterly direction to the Powys/Gwynedd County boundary at Dyfi Bridge, north of Machynlleth;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 08.00 hours on 8 December 2014 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restrictions and Prohibition

- **3.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road, during such times as the restriction referred to in article 5 is in operation.

Application

7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein are indicated by traffic signs.

Duration of this Order

8. The maximum duration for this Order shall be 12 months.
