Mae erthygl 2 o'r Gorchymyn hwn yn diwygio adran 46(4) o Ddeddf 1998 drwy fewnosod cyfeiriad at Ddeddf Sector Amaethyddol (Cymru) 2014 ("Deddf 2014"). Mae'r ddarpariaeth yn sicrhau na ellir erlyn person o dan Ddeddf 1998 a Deddf 2014 am drosedd sy'n codi o'r un ymddygiad.

Nid oes Asesiad Effaith Rheoleiddiol wedi ei lunio ar gyfer y Gorchymyn hwn gan na ragwelir y bydd yn effeithio o gwbl ar y sector cyhoeddus, y sector preifat, y sector elusennol na'r sector gwirfoddol.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order makes a consequential modification to the National Minimum Wage Act 1998 ("the 1998 Act").

Article 2 of this Order amends section 46(4) of the 1998 Act by inserting a reference to the Agricultural Sector (Wales) Act 2014 ("the 2014 Act"). The provision ensures that a person cannot be prosecuted under both the 1998 Act and the 2014 Act for an offence arising out of the same conduct.

A Regulatory Impact Assessment has not been prepared for this Order as no impact on the public, private, charity or voluntary sectors is foreseen.

Title, commencement and application

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf Sector Amaethyddol (Cymru) 2014 (Addasu Canlyniadol) 2015 a daw i rym ar 9 Rhagfyr 2015.

1.—(1) The title of this Order is the Agricultural Sector (Wales) Act 2014 (Consequential Modification) Order 2015 and it comes into force on 9 December 2015.
