## Saving and transitional provisions

- (c) General Teaching Council for Wales (Disciplinary Functions) Regulations 2001(3) continue to have effect until such time as the Welsh Ministers make regulations in exercise of their powers under sections 26 and 28 of the 2014 Act;
- (d) General Teaching Council for Wales (Fees) Regulations 2002(4) continue to have effect until such time as the Welsh Ministers make regulations in exercise of their powers under section 12 of the 2014 Act;
- (e) Education (Induction Arrangements for School Teachers) (Wales) Regulations 2005(5) continue to have effect until such time as the Welsh Ministers make regulations in exercise of their powers under sections 17 and 19 of the 2014 Act;
- (f) Education (Specified Work and Registration) (Wales) Regulations 2010(6) continue to have effect until such time as the Welsh Ministers make regulations in exercise of their powers under sections 14 and 15 of the 2014 Act;
- (g) School Teacher Appraisal (Wales) Regulations 2011(7) continue to have effect until such time as the Welsh Ministers make regulations in exercise of their powers under section 23 of the 2014 Act.
