Mae'r Rheoliadau hyn yn diwygio'r Rheoliadau a nodir isod, ac yn y modd a eglurir, o ganlyniad i bwysau a blaenoriaethu gwaith sy'n gysylltiedig â'r feirws o'r enw'r Coronafeirws neu "coronafeirws syndrom anadlol aciwt difrifol 2", sy'n achosi'r clefyd o'r enw "COVID-19".

Mae'r Rheoliadau hyn yn diwygio rheoliad 4 o Reoliadau Dyfroedd Ymdrochi 2013 er mwyn newid dyddiad cychwyn y tymor ymdrochi yng Nghymru am y flwyddyn 2020.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations make amendments to the Regulations set out below, and in the manner explained, as a result of pressures and work prioritisation related to the virus known as Coronavirus or "Severe acute respiratory syndrome coronavirus 2", which causes the disease known as "COVID-19".

These Regulations amend regulation 4 of the Bathing Water Regulations 2013 in order to change the start date of the bathing season in Wales for the year 2020.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru wedi eu dynodi at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(1) mewn perthynas â mesurau sy'n ymwneud ag adnoddau dŵr(2).

The Welsh Ministers are designated for the purposes of section 2(2) of the European Communities Act 1972(1) in relation to measures relating to water resources(2).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pwerau a roddir gan adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972.

The Welsh Ministers make these Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972.

- (1) 1972 p. 68. Diddymwyd Deddf y Cymunedau Ewropeaidd 1972 ("Deddf 1972") gan adran 1 o Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16) ("Deddf 2018") gan gael effaith o'r diwrnod ymadael ("exit day"). Mae "exit day" wedi ei ddiffinio yn adran 20 o Ddeddf 2018 fel 31 Ionawr 2020 am 11pm. Er gwaethaf y diddymiad hwnnw mae Deddf 1972 yn parhau i gael effaith gydag addasiadau tan ddiwrnod cwblhau'r cyfnod gweithredu ("IP completion day"), yn rhinwedd adran 1A o Ddeddf 2018. Mewnosodwyd adran 1A gan adran 1 o Ddeddf yr Undeb Ewropeaidd (Y Cytundeb Ymadael) 2020 (p. 1) ("Deddf 2020"). Mae "IP completion day" wedi ei ddiffinio yn adran 1A fel 31 Rhagfyr 2020 am 11pm (yr ystyr a roddir yn adran 39 o Ddeddf 2020). Diwygiwyd adran 2(2) o Ddeddf 1972 yn flaenorol gan adran 27(1) o Ddeddf Diwygio Deddfwriaethol a Rheoleiddiol 2006 (p. 51) a chan adran 3(3) o Ddeddf yr Undeb Ewropeaidd (Diwygio) 2008 (p. 7) a Rhan 1 o'r Atodlen iddi.
- (2) *Gweler* O.S. 2003/2901 ar gyfer y dynodiad a roddir i Gynulliad Cenedlaethol Cymru. Yn rhinwedd adrannau 59 a 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32), a pharagraff 28 o Atodlen 11 iddi, mae'r dynodiad hwnnw bellach wedi ei roi i Weinidogion Cymru. Mae O.S. 2003/2901 wedi ei ddirymu'n rhagolygon gan O.S. 2018/1011 o ddiwrnod cwblhau'r cyfnod gweithredu.

- (1) 1972 c. 68. The European Communities Act 1972 ("the 1972 Act") was repealed by section 1 of the European Union (Withdrawal) Act 2018 (c. 16) ("the 2018 Act") with effect from exit day. "Exit day" is defined in section 20 of the 2018 Act as 31 January 2020 at 11pm. Despite that repeal the 1972 Act continues to have effect with modifications until IP completion day, by virtue of section 1A of the 2018 Act. Section 1A was inserted by section 1 of the European Union (Withdrawal Agreement) Act 2020 (c. 1) ("the 2020 Act"). "IP completion day" is defined in section 1A as 31 December 2020 at 11pm (the meaning given in section 39 of the 2020 Act). Section 2(2) of the 1972 Act was previously amended by section 27(1) of the Legislative and Regulatory Reform Act 2006 (c. 51) and by section 3(3) of, and Part 1 of the Schedule to, the European Union (Amendment) Act 2008 (c. 7).
- (2) *See* S.I. 2003/2901 for the designation conferred on the National Assembly for Wales. By virtue of sections 59 and 162 of, and paragraph 28 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), that designation is now conferred on the Welsh Ministers. S.I. 2003/2901 is prospectively revoked by S.I. 2018/1011 from IP completion day.

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Dyfroedd Ymdrochi (Diwygio) (Cymru) (Coronafeirws) 2020 a deuant i rym ar 15 Mai 2020.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

Diwygio Rheoliadau Dyfroedd Ymdrochi 2013

2.—(1) Mae Rheoliadau Dyfroedd Ymdrochi 2013(1) wedi eu diwygio fel a ganlyn.

(2) Yn lle rheoliad 4 (hyd y tymor ymdrochi) rhodder—

“4. For the purposes of these Regulations, the bathing season in Wales—

- (a) subject to paragraph (b), begins on 15th May and ends at the end of the day on 30th September in each year;
- (b) for the year 2020, begins on 22nd June and ends at the end of the day on 30th September.”

Title, commencement and application

1.—(1) The title of these Regulations is the Bathing Water (Amendment) (Wales) (Coronavirus) Regulations 2020 and they come into force on 15 May 2020.

(2) These Regulations apply in relation to Wales.

Amendment of the Bathing Water Regulations 2013

2.—(1) The Bathing Water Regulations 2013(1) are amended as follows.

(2) For regulation 4 (length of bathing season) substitute—

“4. For the purposes of these Regulations, the bathing season in Wales—

- (a) subject to paragraph (b), begins on 15th May and ends at the end of the day on 30th September in each year;
- (b) for the year 2020, begins on 22nd June and ends at the end of the day on 30th September.”
