Diben y Rheoliadau hyn yw rhagnodi gwybodaeth ychwanegol benodol y mae rhaid ei dangos ar bob cofnod yn y gofrestr o ddarparwyr gwasanaethau a gynhelir gan Weinidogion Cymru o dan adran 38(1) o Ddeddf 2016. Mae'r Rheoliadau hyn hefyd yn ei gwneud yn ofynnol i ddarparwyr gwasanaethau hysbysu Gweinidogion Cymru am newidiadau i rif ffôn a chyfeiriad post electronig gwasanaethau sy'n cael eu rheoleiddio o dan Ddeddf 2016.

Mae rheoliad 2 yn darparu bod gwybodaeth ychwanegol, ar ffurf cyfeiriad post electronig a rhif ffôn y gwasanaeth, yn cael ei rhagnodi o dan y pŵer a roddir gan adran 38(2)(g) o Ddeddf 2016. Rhaid i'r wybodaeth ragnodedig ychwanegol hon gael ei dangos ar y gofrestr mewn cysylltiad â phob man lle y darperir gwasanaeth, pob man y darperir gwasanaeth ohono, neu bob man y darperir gwasanaeth mewn perthynas ag ef.

The Register of Service Providers
(Prescribed Information and
Miscellaneous Amendments)
(Wales) Regulations 2023

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made under powers conferred on the Welsh Ministers by the Regulation and Inspection of Social Care (Wales) Act 2016 (anaw 2) ("the 2016 Act"). The purpose of these Regulations is to prescribe certain additional information which must be shown on each entry in the register of service providers maintained by the Welsh Ministers under section 38(1) of the 2016 Act. These Regulations also require service providers to notify the Welsh Ministers of telephone number and electronic mail address changes for services regulated under the 2016 Act.

Regulation 2 provides that additional information, in the form of an electronic mail address and telephone number for the service, is prescribed under the power conferred by section 38(2)(g) of the 2016 Act. This additional prescribed information must be shown on the register in respect of each place at, from or in relation to which, a service is provided.

Mae rheoliadau 3 a 4 yn diwygio Rheoliadau Gwasanaethau Rheoleiddiedig (Cofrestru) (Cymru) 2017 i osod gofyniad ar ymgeiswyr sy'n ceisio darparu gwasanaeth cartref gofal, gwasanaeth llety diogel neu wasanaeth canolfan breswyl i deuluoedd i ddarparu cyfeiriad post electronig y fangre y bwriedir darparu'r gwasanaeth rheoleiddiedig ynddi. Mae'r diwygiad hwn yn sicrhau bod rhaid i bob ymgeisydd ddarparu'r wybodaeth hon wrth wneud ceisiadau i gofrestru ac i amrywio cofrestriadau ar gyfer pob gwasanaeth rheoleiddiedig o dan Ddeddf 2016.

Mae rheoliadau 5 a 6 yn diwygio Rheoliadau Gwasanaethau Rheoleiddiedig (Datganiadau Blynnyddol) (Cymru) 2017 i gynnwys gofyniad i'r cyfeiriad post electronig a'r rhif ffôn mewn cysylltiad â phob man lle y darperir gwasanaeth, pob man y darperir gwasanaeth ohono, neu bob man y darperir gwasanaeth mewn perthynas ag ef, gael eu cynnwys fel rhan o ddatganiad blynnyddol darparwr gwasanaeth.

Mae rheoliadau 7 i 16 yn diwygio'r Rheoliadau canlynol i ychwanegu gofyniad hysbysu ychwanegol ar ddarparwyr gwasanaethau o ran unrhyw newid i gyfeiriad post electronig neu rif ffôn gwasanaeth rheoleiddiedig:

- (a) Rheoliadau Gwasanaethau Rheoleiddiedig (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2017,
- (b) Rheoliadau Gwasanaethau Maethu Rheoleiddiedig (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2019,
- (c) Rheoliadau Gwasanaethau Eirioli Rheoleiddiedig (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2019,
- (d) Rheoliadau Gwasanaethau Lleoli Oedolion (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2019, ac
- (e) Rheoliadau Gwasanaethau Mabwysiadu Rheoleiddiedig (Darparwyr Gwasanaethau ac Unigolion Cyfrifol) (Cymru) 2019.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Gellir cael copi oddi wrth: Yr Adran Iechyd a Gwasanaethau Cymdeithasol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ ac fe'i cyhoeddir ar www.llyw.cymru.

Regulations 3 and 4 amend the Regulated Services (Registration) (Wales) Regulations 2017 to impose a requirement on applicants seeking to provide a care home service, a secure accommodation service or a residential family centre service to provide the electronic mail address for the premises at which it is intended to provide the regulated service. This amendment ensures that all applicants must provide this information when making applications for registration and for variation of registration for all regulated services under the 2016 Act.

Regulations 5 and 6 amend the Regulated Services (Annual Returns) (Wales) Regulations 2017 to include a requirement for the electronic mail address and telephone number in respect of each place at, from or in relation to which, a service is provided to be included as part of a service provider's annual return.

Regulations 7 to 16 amend the following Regulations to add an additional notification requirement on service providers of any change in a regulated service's electronic mail address or telephone number:

- (a) the Regulated Services (Service Providers and Responsible Individuals) (Wales) Regulations 2017,
- (b) the Regulated Fostering Services (Service Providers and Responsible Individuals) (Wales) Regulations 2019,
- (c) the Regulated Advocacy Services (Service Providers and Responsible Individuals) (Wales) Regulations 2019,
- (d) the Adult Placement Services (Service Providers and Responsible Individuals) (Wales) Regulations 2019, and
- (e) the Regulated Adoption Services (Service Providers and Responsible Individuals) (Wales) Regulations 2019.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers, in exercise of the powers conferred upon them by sections 6(1)(d), 10(2)(a)(ix), 11(3)(a)(iii), 27(1) and 38(2)(g) of the Regulation and Inspection of Social Care (Wales) Act 2016(1) (the “2016 Act”), make the following Regulations(2).

The Welsh Ministers have consulted such persons as they think appropriate as required by section 27(4)(a) of the 2016 Act and have published a statement about the consultation as required by section 27(4)(b) of the 2016 Act. The Welsh Ministers have laid a copy of the statement before Senedd Cymru as required by section 27(5) of the 2016 Act.

A draft of these Regulations was laid before Senedd Cymru under section 187(2)(f) of the 2016 Act and has been approved by a resolution of Senedd Cymru(3).

Title and coming into force
