Mae Rheoliadau Gwasanaethau Rheoleiddiedig (Cofrestru) (Cymru) 2017 (“Rheoliadau 2017”) yn gwneud darpariaeth ynghylch ffurf a chynnwys ceisiadau i gofrestru a cheisiadau i amrywio cofrestrriad o dan Ran 1 o Ddeddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016 (“Deddf 2016”).

The Regulated Services (Registration) (Wales) Regulations 2017 (“the 2017 Regulations”) make provision about the form and content of applications for registration and applications for variation of a registration under Part 1 of the Regulation and Inspection of Social Care (Wales) Act 2016 (“the 2016 Act”).

Rhagnodir gwasanaethau preswyl ysgolion arbennig fel “gwasanaeth rheoleiddiedig” at ddibenion Rhan 1 o Ddeddf 2016 gan Rheoliadau Gwasanaethau Rheoleiddiedig (Gwasanaethau Preswyl Ysgolion Arbennig) (Cymru) 2023.

Special school residential services are prescribed as a “regulated service” for the purposes of Part 1 of the 2016 Act by the Regulated Services (Special School Residential Services) (Wales) Regulations 2023.

Mae'r Rheoliadau hyn yn gwneud diwygiadau er mwyn integreiddio cyfeiriadau at y gwasanaeth rheoleiddiedig newydd hwn yn Rheoliadau 2017.

These Regulations make amendments to integrate references to this new regulated service into the 2017 Regulations.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir gan adrannau 6(1)(d)(1), 11(3)(a)(iii) a 187(1) o Ddeddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016(2), yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred by sections 6(1)(d)(1), 11(3)(a)(iii) and 187(1) of the Regulation and Inspection of Social Care (Wales) Act 2016(2), make the following Regulations.

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Gwasanaethau Rheoleiddiedig (Cofrestru) (Cymru) (Diwygio) 2023.

(2) Daw'r Rheoliadau hyn i rym ar 31 Rhagfyr 2023.

Title and coming into force

1.—(1) The title of these Regulations is the Regulated Services (Registration) (Wales) (Amendment) Regulations 2023.

(2) These Regulations come into force on 31 December 2023.

2. Mae Rheoliadau Gwasanaethau Rheoleiddiedig (Cofrestru) (Cymru) 2017(3) wedi eu diwygio fel a ganlyn—

(a) yn rheoliad 3(b), ar ôl “gwasanaeth llety diogel”, mewnosoder “, gwasanaeth preswyl ysgol arbennig”;

**Amendment of the Regulated Services
(Registration) (Wales) Regulations 2017**

2. The Regulated Services (Registration) (Wales) Regulations 2017(3) are amended as follows—

(a) in regulation 3(b), after “secure accommodation service” insert “, special school residential service”;

(1) Mae adrannau 6(1)(d) ac 11(3)(a)(iii) yn cyfeirio at “unrhyw wybodaeth arall a ragnodir”. Diffinnir “a ragnodir” a “rhagnodedig” yn adran 189 o Ddeddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016 i olygu “wedi ei ragnodi drwy reoliadau a wneir gan Weinidogion Cymru”.

(2) 2016 dccc 2.

(3) O.S. 2017/1098 (Cy. 278). Diwygiwyd y rheoliadau hyn gan O.S. 2019/233 (Cy. 52) ac O.S. 2020/389 (Cy. 87).

(1) Sections 6(1)(d) and 11(3)(a)(iii) refer to “such other information as may be prescribed”. “Prescribed” is defined in section 189 of the Regulation and Inspection of Social Care (Wales) Act 2016 to mean “prescribed by regulations made by Welsh Ministers”.

(2) 2016 anaw 2.
