**Food Protection (Emergency Prohibitions) (Amendment)
Order (Northern Ireland) 1994***Made* 16th December 1994*Coming into operation* 18th January 1995

The Department of Agriculture, in exercise of the powers conferred on it by sections 1(1) and 24(3) of the Food and Environment Protection Act 1985(a) and of every other power enabling it in that behalf, being of the opinion in accordance with section 1(1) of that Act that there exist or may exist circumstances which are likely to create a hazard to human health through human consumption of food and that in consequence food which is or may be in the future derived from sheep in the areas described in the Schedule to the Food Protection (Emergency Prohibitions) Order (Northern Ireland) 1991(b), is, or may be, or may become, unsuitable for human consumption, hereby makes the following Order:—

Title, commencement and interpretation

1.—(1) This Order may be cited as the Food Protection (Emergency Prohibitions) (Amendment) Order (Northern Ireland) 1994 and shall come into operation on 18th January 1995.

(2) The Interpretation Act (Northern Ireland) 1954(c) shall apply to this Order as it applies to a Measure of the Northern Ireland Assembly.

Amendment

2. The areas in Glenshane and Belraugh, County Londonderry and Glenwherry, County Antrim described in the Schedule to the Food Protection (Emergency Prohibitions) Order (Northern Ireland) 1991 shall be substituted by the areas described in the Schedule.

Glenshane, County Londonderry

The area comprising those parts of County Londonderry which lie within the following boundaries:—

- (i) From Currudda townland boundary fence OS Map Ref C791035 south east along field boundary to OS Map Ref C798030; north east to OS Map Ref C800033; south east along stream to OS Map Ref C807030; north east to OS Map Ref C808032; south east to OS Map Ref C809031; north east to OS Map Ref C810032; east to OS Map Ref C812032; north east to OS Map Ref C813035; south east to OS Map Ref C816033; north east to OS Map Ref C817035; north west to OS Map Ref C814038; north along the Pollan Water to Tullykeeran Bridge (OS Map Ref C818045); north along the Tirkane Road to OS Map Ref C812049; west along fence and Altcree Burn which is the boundary between Tullykeeran and Slaghtneil to OS Map Ref C794054; south west along Currudda townland boundary to OS Map Ref C791035.
- (ii) From Fallagloon Bridge (OS Map Ref C781032); north along the Altnamarlagh Burn to OS Map Ref C773043; westward along fences marking the townland boundary between Glenshane and Moydamlaght on the one hand and Corick, Cluntygeeragh and Moneyneany on the other to OS Map Ref C738006; south along the boundary of Moydamlaght Forest to OS Map Ref H750988; south along townland boundary separating Moydamlaght and Dunmurry to OS Map Ref H754975; north east along field boundary to OS Map Ref H755976; south east along river to OS Map Ref H759975; east along Fivemilestraight Road to OS Map Ref H763976; north along Dunmurry Road to OS Map Ref H762977; north along field boundary to OS Map Ref H761980; east along field boundary to OS Map Ref H771983; south east along river to junction with Fivemilestraight Road OS Map Ref H776980; east along Fivemilestraight Road to Campbells Bridge (OS Map Ref H794986); north along river to OS Map Ref H790995; north and east along field boundary to OS Map Ref H791997; east along field boundary to OS Map Ref H796998; north west along townland boundary to OS Map Ref C783010; north east along field boundary to Glenshane Road OS Map Ref C789019; north east to OS Map Ref C796029; north west to OS Map Ref C791034; south and west to Fallagloon Bridge (OS Map Ref C781032).

The area excludes any part of a road, fence or river by reference to which its boundary is defined.

Belraugh, County Londonderry

The area comprising those parts of County Londonderry which lie within the following boundary:—

From field boundary at Evish Burn OS Map Ref C774174 north west to OS Map Ref C769178; north to OS Map Ref C769185; east and south along townland boundary to OS Map Ref C778182; north to OS Map Ref C778190; east to OS Map Ref C790194; north to OS Map Ref C789195; east to OS Map Ref C790196; north westward to OS Map Ref C788198; south westward to OS Map Ref C787195; west to OS Map Ref C786195; north westward to OS Map Ref C781200; west along the Gamlaght River to OS Map Ref C777197; south and west along the boundary of Cam Forest to OS Map Ref C761187; southwards along fences marking the townland

boundary between Coolnasillagh and Temain to OS Map Ref C761178; south and east to Evish Burn and along Evish Burn to OS Map Ref C774174.

The area excludes any part of a road, fence or river by reference to which its boundary is defined.

Glenwherry, County Antrim

The area comprising those parts of County Antrim which lie within the following boundary:—

From the Glenhead Road (OS Map Ref D279998) northwards along the eastern boundary of the Department of Agriculture's Hill Farm to OS Map Ref D306029; westwards along the south and west boundary of Capanagh Forest to OS Map Ref D292054; north-westwards along the Starbog Road to OS Map Ref D288063; westwards along fences to OS Map Ref D264057; westwards along the Drumcrow Road and Shillanavogy Road to OS Map Ref D249048; westwards along the Shillanavogy Water and fences which form the townland boundary between Shillanavogy and Ballynacaird to the Douglas Burn (OS Map Ref D239043); southwards along boundary fence to OS Map Ref D244004; eastwards along boundary fence to Shillanavogy Road (OS Map Ref D256005); southwards along Shillanavogy Road to OS Map Ref D258998; eastwards along fences to the Glen Burn (OS Map Ref D259999); southwards along the Glen Burn to the Glenhead Road (OS Map Ref D261997); eastwards along Glenhead Road to OS Map Ref D269998; northwards along the Department of Agriculture's Hill Farm boundary fence to OS Map Ref D266012; north-eastwards along Department of Agriculture's Hill Farm boundary fence to OS Map Ref D277017; southwards along Department of Agriculture's Hill Farm boundary fence to junction with Glenhead Road (OS Map Ref D277998) and continue eastwards along the Glenhead Road to OS Map Ref D279998.

The area excludes any part of a road, fence or river by reference to which its boundary is defined.

EXPLANATORY NOTE

(This note is not part of the Order.)

The Food Protection (Emergency Prohibitions) Order (Northern Ireland) 1991 (as amended) (the "principal order") contains emergency prohibitions on various activities in order to prevent human consumption of food which is derived from sheep in the designated areas in Northern Ireland and which has been or may have been rendered unsuitable for human consumption in consequence of the elevated levels of radioactivity found in those areas following the escape of radioactive substances from a nuclear reactor situated at Chernobyl in the Ukraine.

This Order amends the principal order by reducing the size of the designated areas in Glenshane and Belraugh in County Londonderry, and Glenwherry, County Antrim.
