### Part 1

# Application of Part IV of the 1989 Act

1. In relation to the transitional period, the provisions of Part IV of, and Schedule 3 to, the 1989 Act (Revenue accounts and capital finance of local authorities) MI shall apply to a National Park authority with the modifications specified in Part II to this Schedule.
