# The Air Navigation (Restriction of Flying) (Epsom) Regulations 2024

Made - - - - 25th April 2024

Coming into force - - 31st May 2024

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intending gathering there of a large number of persons.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Epsom) Regulations 2024 and they come into force on 31st May 2024.

### Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 0900 hours and 1800 hours on 31st May 2024 and 1st June 2024 no unmanned aircraft is to fly below 1,100 feet above mean sea level within the area bounded by a circle having a radius of 1 nautical mile centred at 511835N 0001509W.
- (2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission issued by Sussex Police.

## **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Epsom Downs Racecourse, Surrey during the horse racing festival that is due to take place there on 31st May 2024 and 1st June 2024.

At the request of Sussex Police, the Civil Aviation Authority and the Department for Transport agree that the flying of unmanned aircraft should be restricted in the vicinity of the festival for reasons of public safety and security.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), Sussex Police may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by an Aeronautical Information Service Briefing Sheet and Notice to Aviation (NOTAM).
