Mae'r Gorchymyn hwn yn gwneud diwygiadau canlyniadol mewn perthynas â Deddf Cartrefi Symudol (Cymru) 2013 ("Deddf 2013") a daw i rym ar 31 Hydref 2016.

Mae erthygl 2 yn mewnosod cyfeiriadau at safle cartrefi symudol ac at Ddeddf 2013 yn Rhan B y Tabl yn Atodlen 1 i Reoliadau Awdurdodau Lleol (Trefniadau Gweithrediaeth) (Swyddogaethau a Chyfrifoldebau) (Cymru) 2007.

Mae erthygl 3 yn gwneud newidiadau i reoliadau 2 a 7(1)(a) o Reoliadau Taliadau Sŵn Priffyrdd (Cartrefi Symudol) (Cymru) 2001.

Mae erthygl 4 yn mewnosod cyfeiriad at Ddeddf 2013 yn Rhan 5 o Atodlen 2 i Orchymyn Cynllunio Gwlad a Thref (Datblygu Cyffredinol a Ganiateir) 1995.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order makes consequential amendments in relation to the Mobile Homes (Wales) Act 2013 ("the 2013 Act") and it comes into force on 31 October 2016.

Article 2 inserts references to a mobile home site and to the 2013 Act in Part B of the Table in Schedule 1 to the Local Authorities (Executive Arrangements) (Functions and Responsibilities) (Wales) Regulations 2007.

Article 3 makes changes to regulations 2 and 7(1)(a) of the Highways Noise Payments (Movable Homes) (Wales) Regulations 2001.

Article 4 inserts a reference to the 2013 Act into Part 5 of Schedule 2 to Town and Country Planning (General Permitted Development) Order 1995.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf Cartrefi Symudol (Cymru) 2013 (Darpariaethau Canlyniadol) 2016.

1.—(1) The title of this Order is the Mobile Homes (Wales) Act 2013 (Consequential Provisions) Order 2016.

(2) Daw'r Gorchymyn hwn i rym ar 31 Hydref 2016.

(2) This Order comes into force on 31 October 2016.

**Amendment of the Local Authorities (Executive

(Wales) Regulations 2007**

2.—(1) Mae Atodlen 1 i Reoliadau Awdurdodau Lleol (Trefniadau Gweithrediaeth) (Swyddogaethau a Chyfrifoldebau) (Cymru) 2007(2) wedi ei diwygio fel a ganlyn.

2.—(1) Schedule 1 to the Local Authorities (Executive Arrangements) (Functions and Responsibilities) (Wales) Regulations 2007(2) is amended as follows.

(2) Ym mharagraff 1 o Ran B (swyddogaethau trwyddedu a chofrestru (i'r graddau nad oes unrhyw baragraff arall yn yr Atodlen hon yn ymdrin â hwy))—

- (a) yng ngholofn (1) y Tabl ar ôl “Y pŵer i ddyroddi trwyddedau sy'n awdurdodi defnyddio tir fel safle carafannau”, mewnosoder “neu safle cartrefi symudol”; a
- (b) yng ngholofn (2) y Tabl, ar ôl “Adran 3(3) o Ddeddf Safleoedd Carafannau a Rheoli Datblygu 1960 (p.62)” mewnosoder “ac adran 7(1) o Ddeddf Cartrefi Symudol (Cymru) 2013 (dccc 6)”.

### **Diwygio Rheoliadau Taliadau Sŵn Priffyrdd (Cartrefi Symudol) (Cymru) 2001**

3.—(1) Mae Rheoliadau Taliadau Sŵn Priffyrdd (Cartrefi Symudol) (Cymru) 2001(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2 (dehongli), yn y diffiniad o “cartref symudol”—

- (a) hepgorer paragraff (a);
- (b) ar ddiwedd paragraff (b) yn lle “;” rhodder “, neu”; ac
- (c) ar ôl paragraff (b) mewnosoder—  
“(c) cartref symudol o fewn ystyr adran 60 o Ddeddf Cartrefi Symudol (Cymru) 2013;”.

(3) Yn rheoliad 7(1)(a) (cartrefi cymwys)—

- (a) yn lle “carafân, wedi'i lleoli'n” rhodder “cartref symudol, wedi'i leoli'n”; a
- (b) yn lle “adran 1(2) o Ddeddf Safleoedd Carafannau 1968” rhodder “adran 2(2) o Ddeddf Cartrefi Symudol (Cymru) 2013”.

### **Diwygio Gorchymyn Cynllunio Gwlad a Thref (Datblygu Cyffredinol a Ganiateir) 1995**

4. Yn Rhan 5 o Atodlen 2 i Orchymyn Cynllunio Gwlad a Thref (Datblygu Cyffredinol a Ganiateir) 1995(2), o dan Ddosbarth B (datblygu a ganiateir) ar ôl “the 1960 Act” mewnosoder “and the Mobile Homes (Wales) Act 2013”.

(2) In paragraph 1 of Part B (licensing and registration functions (in so far as not covered by any other paragraph of this Schedule))—

- (a) in column (1) of the Table after “Power to issue licences authorising the use of land as a caravan site”, insert “or mobile home site”; and
- (b) in column (2) of the Table, after “Section 3(3) of the Caravan Sites and Control of Development Act 1960 (c. 62)” insert “and section 7(1) of the Mobile Homes (Wales) Act 2013 (anaw 6)”.

### **Amendment of the Highways Noise Payments (Movable Homes) (Wales) Regulations 2001**

3.—(1) The Highways Noise Payments (Movable Homes) (Wales) Regulations 2001(1) are amended as follows.

(2) In regulation 2 (interpretation), in the definition of “movable home”—

- (a) omit paragraph (a);
- (b) at the end of paragraph (b) for “.” substitute “, or”; and
- (c) after paragraph (b) insert—  
“(c) a mobile home within the meaning of section 60 of the Mobile Homes (Wales) Act 2013;”.

(3) In regulation 7(1)(a) (eligible homes)—

- (a) for “caravan” substitute “mobile home”; and
- (b) for “section 1(2) of the Caravan Sites Act 1968” substitute “section 2(2) of the Mobile Homes (Wales) Act 2013”.

### **Amendment of the Town and Country Planning (General Permitted Development) Order 1995**

4. In Part 5 of Schedule 2 to the Town and Country Planning (General Permitted Development) Order 1995(2), under Class B (permitted development) after “the 1960 Act” insert “and the Mobile Homes (Wales) Act 2013”.

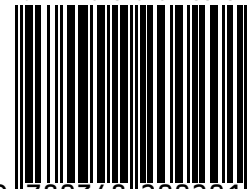
