Mae'r Rheoliadau hyn yn diwygio Rheoliadau Iechyd Planhigion etc. (Ffioedd) (Cymru) 2018 a Rheoliadau Iechyd Planhigion (Ffioedd) (Coedwigaeth) (Cymru) 2019.

Mae rheoliad 2(2) yn diwygio'r ffioedd am wiriadau dogfennol sy'n ymwneud â phlanhigion penodol, cynhyrchion planhigion penodol neu wrthrychau eraill penodol sy'n tarddu o un o Aelod-wladwriaethau'r UE, Liechtenstein neu'r Swistir. Mae hefyd yn darparu nad yw ffi yn daladwy am wiriadau ffisegol na gwiriadau adnabod sy'n ymwneud â nwyddau penodol o Aelod-wladwriaethau'r UE, Liechtenstein a'r Swistir ac yn darparu eithriadau i'r rheol honno.

Mae rheoliad 2(3) yn mewnosod tabl o blanhigion penodol, cynhyrchion planhigion penodol a gwrthrychau eraill penodol y mae'r ffioedd a ddiwygir gan reoliad 2(2) yn ymwneud â hwy. Mae'r tabl yn diweddarau ac yn cywiro'r ffioedd arolygu mewnforio ar gyfer *Solanum lycopersicum* o Morocco a'r Ynysoedd Dedwydd.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Plant Health etc. (Fees) (Wales) Regulations 2018 and the Plant Health (Fees) (Forestry) (Wales) Regulations 2019.

Regulation 2(2) amends the fees for documentary checks relating to certain plants, plant products or other objects originating from an EU Member State, Liechtenstein or Switzerland. It also provides that no fee is payable for physical and identity checks relating to certain goods from EU Member States, Liechtenstein and Switzerland and provides exceptions to that rule.

Regulation 2(3) inserts a table of certain plants, plant products and other objects to which the fees amended by regulation 2(2) relate. The table updates and corrects the import inspection fees for *Solanum lycopersicum* from Morocco and the Canary Islands.

O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Regulation 3 amends the Plant Health (Fees) (Forestry) (Wales) Regulations 2019. Paragraph (2) corrects the type of inspection for which a fee is chargeable under those Regulations.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. **Title and coming into force**

1.—(1) The title of these Regulations is the Plant Health etc. (Miscellaneous Fees) (Amendment) (Wales) Regulations 2024.

(2) They come into force on 9 May 2024.

PART 2

Amendments relating to fees

**Amendment of the Plant Health etc. (Fees) (Wales) Regulations 2018**

2.—(1) The Plant Health etc. (Fees) (Wales) Regulations 2018(1) are amended as follows.

(2) In regulation 3 (import inspection fees)—

(a) for paragraph (2) substitute—

“(2) The fee payable by the importer of a third country consignment in respect of a documentary check of each phytosanitary certificate or phytosanitary certificate for re-export accompanying the consignment is—

(a) in the case of a consignment originating in Liechtenstein containing any plant or plant products falling within the table in Schedule 2B and also within the Schedule to the Official Controls (Plant Health) (Frequency of Checks) Regulations 2022(2), £5.25;

(b) in the case of a consignment to which sub-paragraph (a) does not apply, originating in an EU Member State, Liechtenstein or Switzerland and containing only plants or plant products all falling within the table in Schedule 2B, £0.15;

(c) in any other case, £5.25.”;

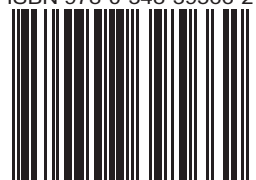
